- Adrienne Rall moves to accept the 2021-2023 Budget. So moved by Psi. Seconded by Beta Zeta. Motion passes.
- Report of the Jurisdiction and Finance Committee by Chair Tyler Hern, Southwest District President. (Appendix N).
- The Southwest District moves to accept the following proposals in a block vote. The Western District seconds. Motion passes.
  - Addition of Bylaw 1.105: In light of the importance of maintaining engagement with Alumni, Life, and Honorary members of Tau Beta Sigma, the Board of Trustees recognizes the Tau Beta Sigma Alumni Association as the national alumni association for the Sorority and delegates authority over the Tau Beta Sigma Alumni Association to the alumni association's Executive Council.

- Amendment to Bylaw 1.108: Each member of the Sorority's National 0 Leadership Team, including the Board of Trustees, the National Council, the District Counselors, the Chapter Visitation Assistants, and the members of the Tau Beta Sigma Alumni Association Executive Council, their heirs, executors, and administrators, may be indemnified by the Sorority against the expenses reasonably incurred by such person in connection with any action, suit, or proceeding to which the member may be made a party by reason of serving or having served as a member of the Board or Council Sorority's National Leadership Team, so long as such person is found to have acted in good faith and within the scope of their office. Any such indemnification must be first approved by the National Chapter assembled at a National Convention. Such expenses shall include the cost of reasonable settlement made with a view to curtailment of litigation and reasonable expense incurred in the preparation and trial of the litigation. The foregoing right of indemnification shall not be exclusive of other rights to which such person may be entitled as matter of law.
- Removal of Bylaws 1.109 and 1.110: 1.109 The Tau Beta Sigma Sorority neither approves of nor is responsible for actions of members of local chapters (commonly referred to as "hazing") which may result in injury to persons or damage to property. Hazing is defined as any action taken or situation created, intentionally or through negligence, to produce mental or physical discomfort, embarrassment, harassment, or ridicule. 1.110 The Tau Beta Sigma Sorority expressly prohibits discrimination by any component part of the Sorority or by any person acting on behalf of the organizations on the basis of race, ethnicity, color, national origin, sex, ability status, religion, age, marital status, veteran status, gender identity or expression, or sexual orientation.
- Amendment to Bylaw 2.101: The Corporation shall have jurisdiction over all component parts of the Sorority and shall represent them and approve all decisions in matters of National Policy, alumni, public relationship, legal action, and controversy which may be referred to its Board of Trustees by the National Chapter or the National Council, or the Tau Beta Sigma Alumni Association Executive Council. The decision of the Board of Trustees shall be final in all cases.
  - Iota Omega moves to amend bylaw 2.101 and replace the "or" following National Chapter with a comma. Delta Xi seconds. The Southwest District accepts the amendment. The Western District accepts the friendly amendment. Motion passes.
- Removal of Bylaw 2.104: Mrs. Janet West Miller, past National President, shall be a permanent honorary member of the Board of Trustees of the Sorority, but shall not have a vote on the Board.
- Amendment of Bylaw 3.801: A report of the activities conducted during the biennium shall be submitted by each National Officer, the Board of Trustees Chair, and each District President, and the National Chapter Field Representative at each regularly called Convention of the National Chapter. Each Chairperson of a Standing or Special Committee shall submit a report of the activities of the Committee, together with the Committee's recommendations, at each convention of the National Chapter. All reports shall be typewritten and submitted in hard

copy clectronically to the National President, the National Vice President for Communication and Recognition, and the National Executive Director. An additional copy shall be submitted via electronic format to the National Vice President for Communication and Recognition. One copy of all reports shall be filed at the National Headquarters by the National Executive Director.

- Amendment to 5.402: Each District Officer shall be at least a sophomore student, as defined by the student's college or university, and an Active member of the Sorority in good standing, at the time of election. Officers elected during their final year of college may serve out their current term of office, provided that a complete Life Membership application, including all fees, is filed with National Headquarters prior to the student's graduation. Each District Officer shall have exceptional business or and professional ability and shall be capable of representing the Sorority and District when called upon to do so. Each District Officer shall have the best interest of the Sorority at heart and be willing and able to devote the necessary time to execution of the duties imposed by the office and shall be actively participating in or serving bands during their term of office. All District officers shall serve without compensation.
- Amendment to Bylaw 5.404: The District President shall preside at all meetings of the District and shall be a nonvoting member of all District Committees, with the exception of the Nominations Committee which they shall appoint, and shall render all possible assistance to the District Counselor. In the absence of the District Counselor, the District President may be designated as the official rep representative of the District whenever such representation shall be required.
- Amendment to 5.601: A regularly called meeting of the District shall be held on a yearly basis. The exact date is to be determined by the host chapter subject to the approval of the majority of the District Counselor and Governors. In the absence of a decision by the close of the District Convention, the District Counselor and Governors will determine the location for the next convention. The District Counselors and Governors will determine the location and date for each District Convention in conjunction with the National Headquarters and the National Presidents.
- Removal of Bylaw 5.902: A report of the activities of the office held shall be submitted in triplicate by each District Delegate at regularly called National Conventions.
- Amendment to Bylaw 6.201: The officers of a chapter shall be: President, Vice President **of Membership**, Secretary, <del>and</del> Treasurer, **and** other officers as deemed necessary by the individual chapter.
- Amendment to Bylaw 6.606: ASSOCIATE. Associate Membership is granted to a
  member of Kappa Kappa Psi who transfers to a college or university which does
  not have an Active Kappa Kappa Psi chapter. The member must meet the
  requirements as defined in the present transfer policy 6.622. Before becoming
  eligible for Associate Membership, the potential Associate member must be
  educated in the Ritual, operations, and traditions of Tau Beta Sigma. Associate
  members have all of the rights, privileges, duties, and responsibilities of Active
  members. Any exceptions must be approved by the National Council.
- Change all mentions of the National Vice President for Colonization &

**Membership** in the National Constitution to **National Vice President for Membership & Expansion.** Change all mentions of **Colony** in the National Constitution to **Petitioning Group.** 

 The Southwest District moves to approve the following amendments to Bylaw 3.304: Between conventions, the financial policies of the National Chapter shall be governed by a seventy-five (75) percent favorable vote of the National Council. The National Council may also implement a biannual increase in initiate fees and membership dues to not exceed five (5) dollars at the beginning of each biennium with a seventyfive (75) percent favorable vote of the National Council. Any increase in excess of five (5) dollars must be voted on by the National Delegation by simple majority. Delta Nu seconds. Gamma Omega moves to table discussion. Rho seconds. Discussion tabled.

Brief recess at 3:56PM, meeting called back to order at 4:03PM.

- Board of Trustee Capital Development Co-Chair Jason Dornbush reports that there has been \$11,000 donated to the trust from the capital development campaign this week.
- Iota Alpha moves to approve the proposed amendments on bylaw 3.304. Delta Alpha seconds. Motion passes.
- The Credentials and Resolutions Committee presented the following awards:
  - Chapter Distance Award: Theta Sigma
  - o Janet West Miller Delegate Distance Award: Julia Robles, Eta Omega
  - District Participation Award: Southeast District
  - Chapter Participation Award: Theta Sigma
- The History & Traditions/Ritual & Regalia Report was presented by Co-Chairs Misty Lovejoy and Aubrey Zide (Appendix O).
- The North Central District moves to approve the suggested lyric changes to the Loyalty Song: change "God grant us strength to be/Renewed to join with thee" to "We have the strength to be/And fortitude to serve and lead." The Western District seconds. Psi makes a friendly amendment to change to "we have the strength to be and fortitude to serve and lead." (changing with to and). Southwest District seconds. Amendment passes. Gamma Omega moves to close discussion. Zeta Omega seconds. The Southeast District moves to vote for the lyric change by secret ballot. Motion passes.

## 2021-2023 National Council Officer Elections

- Theta Theta moves to advance Erika Pope to the office of National President by acclamation. The Southwest District seconds. Motion passes.
- President Rall opens the floor for nominations for the office of National Vice President for Membership & Expansion.
  - No nominations
- Eta Sigma moves to elect Siobhan Wilkes to the position of National Vice President for Membership & Expansion by acclamation. Epsilon Beta seconds. Motion passes.
- President Rall opens the floor for nominations for the office of National Vice President for Special Projects.
  - Alpha Xi nominates Allison Leemann.
  - Allison Leemann declines.
- President Rall entertains a motion to elect Leslie Gartin to the position of National Vice President for Special Projects by acclamation. So moved by the Southeast District. Seconded by Iota Chi. Motion fails. Election will occur by secret ballot. Leslie Gartin is voted into the position of National Vice President for Special Projects.
- President Rall opens the floor for nominations for the office of National Vice President for Communication & Recognition.
  - Delta Omicron nominates Allison Leemann.
  - Allison Leemann accepts.
- The voting for the National Vice President of Communication & Recognition will occur by secret ballot. Allison Leemann is voted into the position of National Vice President of Communication & Recognition.
- National President Adrienne Rall presents her report. (Appendix P).
- The 2021-2023 National Leadership Team is installed by outgoing President Adrienne Rall.
- National President Erika Pope gives her 2021-2023 Vision Statement. (Appendix Q).
- Theta Mu moves to award Adrienne Rall Life Membership into the National Chapter of Tau Beta Sigma. The Midwest District seconds. Motion passes.
- Delta Tau moves to adjourn. Delta Omicron seconds. Motion passes.

## **APPENDIX A: STANDING RULES**

The Rules for Tau Beta Sigma National Convention:

1. All business sessions shall begin promptly at the place and hour specified on the Convention Program.

2. All reports shall be submitted electronically to the NVPCR prior to presentation, unless otherwise specified by the NVPCR.

3. Reports of committees that would change the Constitution must be referred to the Jurisdiction Committee for review and approval before presentation to the floor.

4. Any member desiring the floor shall rise, state clearly their name and the name of the Chapter which they represent (either as a delegate or proxy).

5. The chair, at their discretion, may recognize individuals other than the delegates and proxies who wish to discuss a motion on the floor. Those individuals are subject to the same frequency and time restrictions as delegates and proxies.

6. No one, other than a member of the National Council, shall speak more than twice during the same session to the same question, and not longer than three minutes at one time without permission of the Convention. The question of granting permission shall be decided by a two-thirds vote without debate.

As a result, we experienced an increase in scholarship submissions for this biennium to 75 applicants compared to the 57 applications from the 2017-2019 biennium.

We have welcomed numerous new leadership members to help guide the Sorority for the future, from Counselors, a New Board of Trustee, Chapter Visitation Assistants, and new Committee members. Tasked with overseeing the financial stability, and long term investments of the corporation, the Trustees found the need for added awareness as job loss and economic hardship became prevalent. Suddenly asking for donations in a time when many were out of work did not seem appropriate. We readjusted our plans while remaining patient, and hopeful that tides would soon turn.

In addition to the challenges of the pandemic, the Sorority mourned the loss of first National President Doris Kochanek, as well as our matriarch and only remaining life member of the Board of Trustees, Janet West Miller. Their passing impacted many who valued their friendship and words of wisdom.

Through it all we remained cautiously optimistic, and the outcomes for biennium showed that we are indeed capable of weathering a storm.

## **Properties**

Tau Beta Sigma can now check "buy and sell property during a pandemic" off their bingo card. In April of 2020 the Sorority purchased, along with the Brothers of Kappa Kappa Psi, a 3900 sq. ft. office building referred to as The Annex. This office is just 2-3 block from Stillwater Station and provides our staff with a modern workspace

In addition to the purchase of the Annex, the joint organizations determined it was time to sell the Duck Street property due to the overall risk and liability it brought the organization. The sale of this building closed in December of 2020.

## Finance

Financially we are doing well. In the words of our investment advisor, we have a "nice little biennium" which is what we like to hear. Our portfolio is currently working well for us, but is something we continue to evaluate to tweak as needed. Along with the addition of a second property comes the addition of expenses and

This role was especially important this biennium as we celebrated our 75th Anniversary. We are ecstatic that we will have 18 Past National Presidents joining us this week as we celebrate their Legacy and look ahead to our next 75 years.

## Capital Development

Our capital development team oversees all fundraising campaigns and donor cultivation and recognition. This biennium, the accomplishments of our capital development committee included the following: Re-created and updated the online donation portal, reconciled multiple TBS Amazon Smile Accounts to just a single account, cultivated donors via emails, handwritten notes and post cards, executed a successful Giving Tuesday campaign which generated over \$14,000 in income in a 24 hour period, launched a life membership special on our 75th Anniversary which brought us to 300 new life members for the biennium, continued the creation of the Legacy Society to recognize people who have included Tau Beta Sigma in their planned giving and estate planning, hosted the Legacy reception along with Kappa Kappa Psi, and launched the "Building the Foundations for the Next 75 Years Campaign" with a fundraising goal of \$250,000, the highest goal ever for our organization. 

## **APPENDIX E: Report of the Assessment Committee**

Report of the 2019-2021 Biennium Assessment Committee

The 2019-2021 Biennium Assessment Committee was charged with the following:

- 1. Review the report of the 2017-2019 Assessment Committee.
- 2. Gather most recent versions of the following data: Chapter Summary Reports, Focus on Five participation, 2019 National Convention Chapters seated, Chapter statuses, and any other data deemed appropriate.
- 3. Maintain open communication lines with the National Council to provide data and support needed for ongoing initiatives.
- 4. Continue to analyze data and answer questions regarding facets of Tau Beta Sigma, pushing the Organization in a positive direction.
- 5. Provide feedback to Headquarters regarding potential future changes to increase the useability of data being stored.

The Assessment Committee continued to meet on a monthly basis this past biennium. With the majority of the last biennium being spent collecting data, we spent the first part of the current biennium understanding what questions we can answer with the data we have and how we could improve our current data collection. Our major initiatives this biennium took shape as the National Organization put focuses on hazing prevention and education, and improvements to our Online Membership Reporting System - more commonly known as OMRS.

While the move to OMRS was a great stepping stone for our Organizations to be able to jump into the tech age, there have always been difficulties with some of the reporting and getting the information needed out of it. This biennium the Assessment Committee took a serious look at what OMRS would look like in a utopia. This included evaluating user stories from multiple perspectives, conducting interviews with individuals from different aspects of our Organization to better understand what OMRS improvements could be done to help them, and an in-depth look at our current forms to see what improvements could be made so our data coming in would be easier to digest and use.

A new area of focus for the Assessment Committee this biennium was Overture. With the program being fully adopted at the beginning of the biennium, we were able to better understand our Chapters' Membership Education Processes from start to finish, and what module activities were being utilized. In addition to information about Overture activities, this data collection provides a clear picture of when Chapters conduct their member education programs each year

which will help the National Council to provide resources and timely guidance to support member educators. For 2020-2021 the majority of Chapters conducted a 6-9 week MEP, typically beginning about one month into a given semester. While we recognize that Covid made the past year's data a bit of an anomaly, we are excited to continue to use this information moving forward to support the Curriculum Development Committee as they update and revise Overture to be relevant and useful for Active Chapters.

The Assessment Committee also took a look at our District Council make-up over the past few years. We asked Counselors to help us understand some information about their District Officers including their year in school, how they were elected, and if they had been on council previously. We found that the large majority of District Officers this biennium were rising Seniors or Life Members and that nearly all were elected to the District Council via the Nominations process, meaning that they submitted a candidate packet and participated in the Nominations Committee process at District Convention prior to election. As we continue to collect this data the Committee hopes to track trends in the school year of the incoming District Councils and identify opportunities for District Council-candidate recruitment.

This year several National Leadership Team members were able to become certified in Hazing Prevention Education and Investigations. This process led the Assessment Committee to begin a review of instances where a Chapter was investigated for potential policy violation over the past decade. A form was created for National Headquarters staff to both compile information from prior investigations and collect information as future investigations arise. This data will then be available to help the National Council better understand the issues our Chapters have faced, and help identify opportunities to prevent behaviors or events that violate risk management policies before they occur.

Another effort that stemmed from this National Leadership Team training this biennium was the creation of the Tau Beta Sigma Biennial Climate Survey. Climate surveys are used to understand the general environment of an organization and the current experience of its members. The results of the survey may identify needs for additional resources or training, highlight strengths to leverage within the organization, and can be used to observe trends in membership over time. Over the past five months, Allison Leemann and myself designed the Tau Beta Sigma Climate Survey to establish a baseline for the Active members' experience. This includes areas such as operations, national programs, and attitudes around risk management and hazing. The survey takes about 15 minutes to complete and will be released to all Active members this fall. Results from the survey will be used to tailor education, programs, and resources to support Active members and Chapter needs. This is the first climate survey for our Organization in over thirty years and it is our intent to repeat the survey each biennium in order to measure organizational progress over time. Thank you to our National Leadership Team members and Chapter Leadership Finalists for taking part in our beta testing earlier this year. We hope that all of you here today and the rest of your Chapters will participate in the climate survey in the fall so that we can better understand the current state of your Chapters and provide support and resources where they are needed.

Moving forward we would like to see the 2021-2023 Assessment Committee continue to be utilized to provide data to back up decisions being made, and provide new perspectives that may be missed otherwise. We would also like to see the 2021-2023 Assessment Committee further

our analytics capacity with the upcoming updates to OMRS and provide recommendations to the National Council related to hazing prevention and education.

Special thanks to Aaron Moore for providing access to whatever data we needed and to the National Council for continuing to let us data nerds geek out. Thank you to Allison, Lauren, and Jonathan for making the past biennium one filled with tough questions, great discussions, and acceptable tangents.

The Committee charges the 2021-2023 Assessment Committee with the following:

- 1. Gather most recent versions of the following data: Chapter Summary Reports, Focus on Five participation, 2021 National Convention Chapters seated, Chapter statuses, and any other data deemed appropriate.
- 2. Maintain open communication lines with the National Council to provide data and support needed for ongoing initiatives.
- 3. Continue to analyze data and answer questions regarding facets of Tau Beta Sigma, pushing the Organization in a positive direction.
- 4. Incorporate new data collection processes and reporting with the updated OMRS.
- 5. Maintain and provide data from the Risk Management Investigations tool to the National Council
- 6. Launch the first Biennial Climate Survey this fall to better understand the current state of our Chapters.

1. Provide the Assessment Committee with desired insights well ahead of key meetings.

The Committee charges the National Vice President for Special Projects with the following:

1. Continue to provide Focus on Five participation data to the Committee once the appropriate years have been completed.

1. Continue to collect and provide information related to Overture to the Assessment Committee for better understanding of Chapters' membership education processes.

## **APPENDIX G: Report of the National Vice President for Special Projects**

It has been a pleasure to serve as the 2019-2021 National Vice President for Special Projects for Tau Beta Sigma. These past two years will forever be ingrained in our memories, and I hope that I have found myself on the right side of history.

For those who do not know me:

My name is Siobhan Wilkes. I identify as female; I am plus-sized, a black woman with braids in my hair. I am an army brat born in Belgium- I am the youngest of three- the first in my immediate family to graduate from the college directly out of high school. My favorite color is green- I am a Gemini. I was undeclared for the first three years of college but settled on hospitality because service is the core of who I am. I use my degree as a hotel revenue manager- no, I do not work in Stillwater and am not employed by Tau Beta Sigma. I am one of three black people on my team, and despite being ambitious at work, I get crippling anxiety that is brought on by the fear of being an imposter because I am different from my coworkers. Throughout my life, I have had to deal with microaggressions from my coworkers and peers, and more recently

by other black people because I do not fit "societies" conception of being a black woman. I care deeply about the work I do for Tau Beta Sigma- I am a Volunteer- My name is not Nationals.

Why did I share all of that with you? It's because I am just like you. All of your national and district leadership are just like you- Sisters who want to support those who serve college bands. As a Black woman leading this organization, I have had to put my trauma and feelings aside to do what is best for our members. However, many of our active members and alumni have forgotten over this past biennium that the people on the other end of the email or those writing statements of solidarity are also humans feeling the same complicated feelings that they are.

To the sisters who could not take the time to find out that the humans attempting to right the wrongs of the past were black women who were suffering with you last June- I forgive you. You have helped me move boldly alongside my fellow council members to make Tau Beta Sigma an organization that will change, never to allow a member to feel the hurt you felt ever again. Each chapter and branch of this organization is a body of humans, and we must use our values to see each other- value each other- and love each other with no reservations.

I could not find a good way to segue into the remainder of my report- and hopefully, this sentence provides a distraction so that I can stop crying.

As NVPSP, my primary responsibility is to encourage each of our chapters to use our national programs to share the art of music and the strength of Tau Beta Sigma with your communities. Tau Beta Sigma chapters were challenged to use our National Programs by participating in the Focus on Five Campaign to serve their surrounding communities through music. The COVID-19 Pandemic made it difficult for many chapters to participate in the "normal" fashion. Still, many of you found the fortitude to think of new and virtual ways to serve their communities while safe at home.

To aid in the success of each chapter, I was able to enhance our current resources and develop additional items to aid in chapter usage of our national programs. It would not be without the assistance of your 2019-2021 District VPSP's. This group of leaders are an invaluable resource for your chapter- many taking on roles to engage with not just Focus on Five Liaisons, but service chairs, sisterhood chairs, and more. In collaboration with these leaders, I was able to

- Beef up the National Program Guides and added additional resources and information
- Publish live FO5 Stats on the National Website to include district stats
- Creating Video and pictorial resources for project completion
- PIVOT National Program Guidance
- And More!

With the support of these leaders, we had 64 chapters complete all of the stripes and the district bonus challenge for this 2019-2020 Focus on Five Campaign. The Pandemic began amidst this Campaign, which disrupted the normal operations that your chapter could complete. Despite this change, SO many of you had the fortitude and courage to keep the Campaign going and used the bonus challenges available to allow us to have record-breaking participation for 2019-2020.

The 2020-2021 Focus on Five Campaign was a little more challenging to complete due to the ongoing threats of the covid-19 Pandemic. We finished the year with 46% of our challenges

complete, the same completion rate of the 2016-2017 campaign. The second part of the biennium was not a setback. Despite all of the barriers your chapter had against you, we still had chapters completing unique and creative National Programs activities.

We welcomed 15 Women in Music Speakers in this biennium who helped continue this program despite our conventions pivoting to the virtual sphere. I sought to identify speakers who brought forward different lived experiences, cultural backgrounds, and professions this year. I was excited to see so many of our speakers leaning into our values as an organization and connecting their lives and experiences with our mission for diversity, inclusion, and women's empowerment in their speeches. Outside of the speakers we welcomed virtually, I am excited for the powerful Women in Music Speakers and Performers we have for the 2021 National Convention: Dr. Rebecca Phillips, Dr. Courtney Snyder, Escape Ten, and Terri Lyne Carrington.

Our National Programs make Tau Beta Sigma unique amongst all of the Greek music organizations. The service we provide to the community and our national programs are SERVICE, give you the opportunity to showcase the heart and the strength of our bond. Use them to enhance the service you provide to your bands and allow your members to use their creativity to make our national programs their own.

I was furloughed from March 26th- October 6th, 2020, and in that time, I offered my skills and infinite time to the Sorority. ## **APPENDIX H: Report of the National Vice President for Colonization & Membership** Sisters of Tau Beta Sigma,

Greetings in the bond of music and service to collegiate bands! I am honored to have the chance to address you once again. I stand before you today humbled, in awe, and inspired by all of you and this wonderful Sisterhood that we get to be a part of. What a time it has been. It has been...well, pick any descriptive word from the English language you like and you would be right. The challenges have been great, but I continue to stand by the fact that the rewards have been even greater.

As the biennium began, I hit the ground running by taking all of the feedback received at National Convention 2019 and putting it into motion in a number of key directions. This included determining the best application of a new chapter status called Observation, planning the National Leadership Conferences for 2020-2021, updating membership specific documents such as the application to start a chapter and the handbook used by charter groups to complete the process, and the larger undertaking of rolling out *Overture*, the National Curriculum for Tau Beta Sigma during the fall semester of 2019. Since the initial roll out, the management of the shared curriculum documents has been overseen by the Tau Beta Sigma National Curriculum Team. This rockstar team includes the personnel of Leslie Gartin, Allison Leemann, Nikki Lyons, Lennie Ambelang, Emily Donovan, Neil Bleiweiss, and newcomer Christopher Lukasik. The myriad of ways in which they managed the curriculum included:

- Working with our National Publications Manager to create the logo and style branding for the *Overture*.
- Conducting routine reviews of each document and making edits as needed for the sharing of updated versions with Membership Educators. Many of the edits were based on feedback received during each of the virtual conventions for 2020 and 2021.

- Assisting in the management of the Membership Education Plan Form and making sure that the content being collected was relevant to the execution of *Overture*.
- Creating and developing an accompanying workbook for Membership Candidates to use during implementation of the Modules, which in turn allowed for the eventual delineation of what are now known as the *Overture* Educator's Manual and the *Overture* Membership Candidate Workbook.

The launching and maintenance of *Overture* was deemed a monumental success...And then the world shut down. As several chapters were forced to press pause on their Spring 2020 Membership Candidate Classes, the National Curriculum Committee leapt into action and were extremely instrumental in helping Membership Educators, by developing resources to assist them in being able to finish the process in a virtual format.

As we continued to navigate the unknown of Covid-19, it was necessary for many of our normal operations to be halted or transitioned to a virtual setting. I can truly say, this whole experience has invented lots of new phrases in much of our day to day and there's one in particular that I never imagined I would utter in relation to the Sorority's most sacred tradition: *Virtual Ritual Experiences (VREs)*.

Working collaboratively with a variety of members from the National Leadership Team, beginning in September 2020 and continuing through the Spring 2021 semester, we were able to host a total of 383 VREs over Zoom Video Communications.

While this method was unorthodox and not ideal, we were able to offer our newly initiated members of the organization an opportunity to experience the defining themes of our Rituals, while allowing chapters to interact with National Leaders who they normally would not have had the chance to do. Huge thank you to all of the National Leadership Team members who went along with me on the fast, yet rewarding ride of administering each of the VREs. I am in awe of the ways in which you all came through for our students and how you were able to add a sense of normalcy to an operational piece that will always be best served in person.

During the biennium, the Council faced the heavy decision of having to close six chapters, for reasons such as having no registered Active members during a school year, Directors of Bands making the conscious decision to close their chapter due to a lack of participation or motivation towards band service, and universities making the decision to not allow Tau Beta Sigma to remain on their campus at this time. I share this information with you, to pose the challenge that as each of you go back to your chapters, really take the time to re-evaluate the projects undertaken by your group and identify the ways in which they not only add value to your band program, but they fit within the ideals of our organization.

Switching gears to a more positive note, the Sorority was able to expand and grow, despite not being able to be in person. We were able to welcome and welcome back the following chapters:

- Slippery Rock University, Installed as the Kappa Alpha Chapter (Advisors: Megan Enright, Ted McCadden, and Kat Howell; Ritual Team Chapter: Gamma Omega, University of Pittsburgh)
- Langston University, Reinstalled as the Delta Alpha Chapter (Advisors: Siobhan Wilkes, Kathy Webster, and Erika Pope; Ritual Team Chapter: Alpha, Oklahoma State University)
- Albany State University, Reinstalled as the Zeta Kappa Chapter (Advisors: Nikki Lyons, Neil Bleiweiss, and Lauren Harrison-Funk; Ritual Team Chapter: Iota Psi, Kennesaw State University.

As I wrap up my time as the National Vice President for Colonization & Membership, I would like to take the time to thank the following groups and individuals.

- Thank you to our wonderful National Headquarters Staff. They have been our rocks even more so than during a normal biennium.
- Thank you to the TBS Board of Trustees and TBS Alumni Association for your continued support in the work we do to enhance the membership experience for our Active students.

Your role evolved into so much more this biennium than we ever could have imagined and we will forever be indebted to you.

### **APPENDIX I: Report of the National Vice President for Professional Relations**

### 2021 NIB

While the planning and execution of the 2021 National Intercollegiate Band was fraught with challenges due to COVID-19, it ultimately ended as an extremely successful, meaningful, and positive musical event. The conductor, Dr. Cynthia Johnston Turner was brought in as a replacement to the originally contracted Virginia Allen. Dr. Allen did not feel comfortable traveling during the pandemic; however, Dr. Turner was a fabulous fit for the realization of composer Alex Shapiro's commissioned piece *SUSPENDED*.

### NIB Makeup

After 135 auditions the following instrumentation was selected:

6 fl	2 ob	9 cl	2 b.cl	2 bsn	4 saxes	1 piano
6 hn	6 tpt	2 euph	2 tuba	4 tbn	1 b.tbn	7 perc

The string bass player was hired from the Grand Rapids Symphony and participated in one full rehearsal, dress rehearsal, and performance. All appearances were paid union rates (contract worked out by Steve).

This year's NIB was smaller with only 54 members representing 37 colleges and universities across the country. The F. Lee Bowling Award for the highest attendance per school went to Texas Tech University with 4 participants. Bowling Green State University & The University of North Texas were next with 3 participants each.

### **COVID-19** Mitigation

Initial planning accounted for 6-foot spacing between players; however, protocols changed to allow for 3-feet spacing between aerosol producing instruments. This proved necessary as the stage measurements were established without the shells. Once shells were in place, the stage would not have accommodated a 6-foot spacing with natural arcs. In addition to spacing, players were asked to

wear masks when not playing and use bell covers for the duration of rehearsals. Bell covers were used for every rehearsal until the dress where the conductor asked players to remove them for the concert. Therefore, while covers were used for all rehearsals, they were not present for the final performance. The final mitigation measure included rehearsal blocks of roughly 50 minutes followed by a ventilation break of 15-20 minutes.

### **Union Workers**

Because the hall staff were union workers, we navigated rules/regulations. These added extra communication and cost in the following areas:

- 1. Use of piano: baby grand vs. grand
- 2. Stage staff for regular rehearsals (1) vs. stage staff for rehearsals with electronics (3)
  - a. It should be noted that when union workers manage the hall ALL equipment used must belong to the hall.
- 3. Use of electronics: ear pieces, monitors, speakers.

### Instruments

The following instruments were borrowed for the execution of the NIB:

Bari Saxophone

Percussion - most from Wayne Bovenschen from Oklahoma State and some from Scott Boerma from Western Michigan University

### **Composer's Assistant**

Incoming VPPR LaToya Webb and band director Yuji Jones served as composer's assistants. This was incredibly helpful as the composer had difficulty seeing the score. (Alex Shapiro recently had eye surgery) \*This is a useful tool in general as it's difficult to mark/listen/comment in real time.

### **Unexpected VPPR Costs**

During the event, I made the following unexpected purchases for NIB

- 1. 4 additional scores: 11x17
  - a. These were at the request of the composer and conductor and were used by conductor, composer, myself, and composer assistant
- 2. Headphones and Ear Adapter Kit
  - a. Conductor needed new/different headphones for the electronic click-track as the hall set did not fit securely in her ear.

### Schedule

We noticed the schedule on the NIB website and the schedule in the HQ staff spreadsheet were not the same. This was easily rectified. In the future, it may be helpful to have the NIB schedule on the NatCon event app for students who participate in both.

### **Reading Band**

Reading Band did not occur during 2021 due to COVID but will resume in 2023.

### **APPENDIX J: Report of the Nominations Committee**

The 2021 Nominations Committee was charged with the following:

- 1. Review the 2019 Nominations Committee Report.
- 2. Determine the eligibility of the candidates for National Council as outlined in the Tau BetaSigma National Constitution.
- 3. Develop interview procedures, formulate questions, and schedule interview times for all candidates for National Office.
- 4. Recommend a slate for candidates for National Office.
- 5. Make decisions that reflect the best interest of the sorority.

We determined the eligibility of each candidate for National Office based on the requirements outlined

in articles 3.203, 3.204, and 3.205 of the 2019-2021 Tau Beta Sigma National Constitution.

3.203 Each National Officer shall be a Life Member of the Sorority in good standing and at least twenty-five (25) years of age at the time of election. Each National Officer shall have completed an undergraduate degree program. Each National Officer shall possess outstanding business ability and shall be capable of representing the Sorority under all ordinary conditions. All shall be willing and able to devote the necessary time to the execution of the duties imposed by the office and shall be actively participating in or serving bands during their term of office.

3.204 [...] The National President and Vice President for Colonization and Membership shall not be eligible for reelection.

3.205 [...] In addition, the National President shall have held at least one national office.

The candidates briefly introduced themselves in our separate session. They also spoke during our mixed caucuses on Wednesday, where they reintroduced their platforms and took questions from the delegates. Each of the candidates for National Office had submitted application packets prior to convention. The committee met for a total of  $3\frac{1}{2}$  hours. In our first hour we revised and

updated the set of interview questions and accepted a schedule for the interviews based on the amount of time each candidate would take to interview - 30 minutes for President and VPCM; 25 minutes for VPSP and VPCR. On Tuesday we interviewed the candidate for President. On Wednesday we interviewed candidates for VPCM, VPSP, and VPCR.

The questions we asked were as follows:

### **GENERAL QUESTIONS:**

- 1. "What is your greatest achievement outside of TBS and how can you apply the skills you learned to your office?"
- 2. "Scenario: You are about to roll out a new program, process, or information how do you plan to communicate it to the chapters and encourage them to actively participate?"
- 3. "What is a personal difficulty that you faced? How did you overcome it and what did you learn?"
- 4. "How do you plan to balance your professional life with this profession?"
- 5. "What past experiences have you had that make you qualified for this position?"

### **PRESIDENT ONLY**

1. "What is your vision for the biennium and the 2023 convention?"

### **VPCM ONLY**

- 1. "Do you have plans to modify Overture in any way, and if so, how do you believe those will benefit the organization?"
- 2. "What will be your approach to (expansion) in the biennium?"

- 2. "How do you intend to encourage participation from chapters who currently have low participation rates?"

- 2. Is there anything else in your packet, platform, or about you that you have not been able to speak on yet and you would like us to know? (to be asked in the final minutes of the interview)

We used the questions used by the 2019 convention's committee as a base for our questions, but varied them to suit the needs of the coming biennium. We believe this was effective, and candidates were able to share their plans and vision relevant to the current and future of the organization. "General" Question 3 could have been asked in a way the directed the "lesson learned" answer back to how it would influence their leadership; the President could be asked another question or two if interested, though the one question given prompts a very thorough answer; and "All" Question 2 was very effective in receiving a response that let us feel like we knew the candidate's platform more intimately.

The candidates were Erika Pope for President, Siobhan Wilkes for Vice President for Colonization and Membership, Leslie Gartin for Vice President for Special Projects, and Allison Leemann and Sarah Griffith for Vice President of Communication and Recognition.

The Committee charges the 2023 Nominations Committee with the following:

- 1. Review the 2021 Nominations Committee Report.
- 2. Determine the eligibility of the candidates for National Council as outlined in the Tau Beta Sigma National Constitution.
- 3. Develop interview procedures, formulate questions, and schedule interview times for all candidates for National Office.

The Committee charges the 2023 Nominations Committee Chair with the following:

We were very impressed with both applicants, and as such we would like to present two more charges.

- 1. Should Allison Leemann not be elected to the office of VPCR, she should be given every opportunity to remain involved in the operations of the sorority beyond her term as a counselor; whether in a position of prominence on task forces/committees or in another appropriate role.
- 2. Should Sarah Griffeth not be elected to the office of VPCR, we recommend without reservation that she should be elevated to the position of District Counselor at the earliest possible opportunity.

It was an honor to be selected to serve as chair of this committee, and to be given the opportunity to work and interact with so many incredible sisters in this way. I would like to thank our advisors Carolyn McCambridge, Amber Scott, and Alexis Holladay for their support and guidance, and the 5 wonderful sisters serving on this committee for sharing their wisdom and vision for the future of Tau Beta Sigma.

### **APPENDIX K: Report of the Programs Committee**

The 2021 Programs Committee was charged with the following:

- 1. Review the report of the 2019 Programs Committee.
- 2. Review the report from the National VPSP that addresses the state of the national programs.
- 3. Review the National Programs and For Greater Practice Initiative Guides for recommended resources to be developed by the NVPSP.
- 4. Discuss ways to encourage participation in the National Programs amongst chapter members. Discuss ways to encourage participation from chapters who do not traditionally participate in National Programs. Provide these recommendations to the NVPSP as well.

We reviewed the Report of the 2019 Programs Committee along with the report from the National VPSP. From our discussion we would like to offer suggestions for the future of the National Programs.

We want to see the following items incorporated into each program section:

- tips and tricks
- jump start ideas
- general time needed
- suggestions on how the event is attended (hybrid, virtual, and in-person events)
- suggestions for generally accessible timeframe (fall, spring, marching band time, etc)

Another suggestion is to create social media posts that are district specific, at least once a month, to state where chapters are with the FoF campaign. This should be listed by chapters so chapters can have a sense of friendly competition. This could also be the District Vice Presidents of Special Projects duty.

- Consider having more than one FoF liaison from each chapter on the Focus on Five Campaign Facebook Page along with having general information more accessible and understandable to all members. This includes brief posts/videos summarizing the FoF campaign and informating all chapter members what this project entails.
- Encourage the District Vice Presidents of Special Projects to inform, encourage, and excite FoF liaisons to share ideas with one another.
- Encourage FoF liaisons to share the love of the planning and implementation of the National Programs with other chapter members such as Service/Programming Chair.

• With social media posts, include links. For example, on Instagram, create a linktree in the bio for members to be able to click on to be taken to the specific FoF page/standings, Programs Guide, etc.

We would still like to see a bonus piece being offered, whether that is at district or national council discretion. This bonus piece could be earned for noticing effort from chapters, achievable pre-approved events to carry out, etc. We believe a buddy system would be beneficial, especially for chapters who struggle to complete stripes and lyre pieces. This could be based on such things as demographics, needs, and strengths.

Additionally, we would like if chapters that generally have a low percentage of completion were encouraged and given small, achievable goals along the way to increase percentage each year. We think spotlighting those chapters for their improvements and engagements with all stripes and lyre pieces is important recognition. Create an award for these improving chapters, big or little. This could be done by District Vice Presidents of Special Projects at District Conventions. This could also be paired with incentives along the way or at the end for chapters to work towards.

- 2. Review the report from the National VPSP that addresses the state of the national programs.

The committee reviewed the 2019 Colonization and Membership Committee Report.

### Review the report of the National Vice President for Colonization and Membership

The committee reviewed the report of the National Vice President for Colonization and Membership, Erika Pope. We discussed the recommendations for the next NVPCM. While we agree with these recommendations, we want to offer a suggestion to think about how to measure changes of chapter MEPs, if the information submitted is limited. We also want to add the suggestion of perhaps having chapters submit the whole document but highlighting any changes for review.

# Review the implementation of *Overture* and recommend any changes that may be necessary.

The committee thoroughly reviewed *Overture*. We started with the discussion of the order of the activities, specifically learning about the National Council before the individual chapters. Some felt as though this was overwhelming for Membership Candidates and it would be beneficial for MCs to learn about their individual chapter history before learning about the National Council. Others felt as though it was important to understand the vision of the Sorority as a whole before applying it to the chapter level, and chapters should already be mentioning chapter history during recruitment events and throughout MEP, with a suggestion for District VPMs to work with Chapter VPMs to find ways to incorporate chapter history into earlier modules.

We also discussed the title of activities and the need for them to be more descriptive to be more inclusive for those who may not understand the title at first glance. The committee suggested that codes be created for the category of learning activities. Ex. Active Learning -> AL, Reading Reflection -> RR.

# Review the proposed Hazing Prevention Lesson for addition to *Overture* and recommend changes that may be necessary.

The committee reviewed the proposed Hazing Prevention Lesson and supports its recommendation of the addition to *Overture*. The committee discussed the case study on page 12 of the Hazing Prevention Lesson document and the recommendation of mentioning it in Module 0 of *Overture*, however additional discussion suggested stating that hazing prevention would be mentioned throughout *Overture* instead or introducing the question of the case study for Membership Candidates to think about before writing their reflection in Module 5. The committee also recommends that a brief definition of hazing be placed before the case study, as well as a reference to the proposed Hazing Prevention Slide in Module 0.

# **Review the TBS Membership Education Plan Form for 2021-2022 and provide recommendations.**

The committee reviewed the TBS Membership Education Plan form for 2021-2022. We were advised that the TBS Membership Education Plan Form may include the option to only submit recruitment plans in the event a chapter only does recruitment in the fall, and will not take a class until the following semester.

The committee reviewed and discussed the draft of the new *Overture* Landing page for tbsigma.org. We discussed a slight deadline extension for submission of MEPS, based on when the new *Overture* Landing page is officially published, however we understand the priority for recruitment events to be submitted, and that there must be enough time to review MEPs before any membership activities begin.

#### **APPENDIX N: Report of the Jurisdiction and Finance Committee**

The 2021 Jurisdiction and Finance Committee was charged with the following:

- 1. Review the report of the 2019 Jurisdiction Committee
- 2. Review the Constitution and make sure it reflects the current business practices of the sorority
- 3. Charge the 2021-2023 National Council with updating Constitution Article Numbers.
- 4. Review the Chapter and District Budget templates and provide feedback to the National Council on possible revisions.
- 5. Charge the National Council as needed with providing additional resources regarding Chapter Budget and finance needs.

For Constitutional Revision Proposals, the Jurisdiction and Finance Committee reviewed each proposal brought to the committee with thoughtful discussion. Each proposed change contains the change along with a rationale for the change being proposed to the delegation. These proposed changes include:

a. The addition of bylaw 1.105

**Proposed:** 1.105 In light of the importance of maintaining engagement with Alumni, Life, and Honorary members of Tau Beta Sigma, the Board of Trustees recognizes the Tau Beta Sigma Alumni Association as the national alumni association for the Sorority and delegates authority over the Tau Beta Sigma Alumni Association to the alumni association's Executive Council.

**Rational:** In order to make the references to TBSAA that come in the other sections later in the Constitution, the organization and the term 'Executive Council' have to be defined somewhere near the beginning.

#### b. 1.108

**Current:** Each member of the Board of Trustees and National Council, their heirs, executors, and administrators, may be indemnified by the Sorority against the expenses reasonably incurred by such person in connection with any action, suit, or proceeding to which the member may be made a party by reason of serving or having served as a member of the Board or Council, so long as such person is found to have acted in good faith and within the scope of their office. Any such indemnification must be first approved by the National Chapter assembled at a National Convention. Such expenses shall include the cost of reasonable settlement made with a view to curtailment of litigation and reasonable expense incurred in the preparation and trial of the litigation. The foregoing right of indemnification shall not be exclusive of other rights to which such person may be entitled as matter of law.

**Proposed:** Each member of the **Sorority's National Leadership Team, including the Board of Trustees, the National Council, the District Counselors, the Chapter Visitation Assistants, and the members of the Tau Beta Sigma Alumni Association Executive Council,** their heirs, executors, and administrators, may be indemnified by the Sorority against the expenses reasonably incurred by such person in connection with any action, suit, or proceeding to which the member may be made a party by reason of serving or having served as a member of the **Board or Council Sorority's National Leadership Team**, so long as such person is found to have acted in good faith and within the scope of their office. Any such indemnification must be first approved by the National Chapter assembled at a National Convention. Such expenses shall include the cost of reasonable settlement made with a view to curtailment of litigation and reasonable expense incurred in the preparation and trial of the litigation. The foregoing right of indemnification shall not be exclusive of other rights to which such person may be entitled as matter of law.

Rationale: This is an important legal distinction that needs to be made.

#### c. 1.109 and 1.110

**Current:** 1.109 The Tau Beta Sigma Sorority neither approves of nor is responsible for actions of members of local chapters (commonly referred to as "hazing") which may result in injury to persons or damage to property. Hazing is defined as any action taken or situation created, intentionally or through negligence, to produce mental or physical discomfort, embarrassment, harassment, or ridicule.

1.110 The Tau Beta Sigma Sorority expressly prohibits discrimination by any component part of the Sorority or by any person acting on behalf of the organizations on the basis of race, ethnicity, color, national origin, sex, ability status, reliegion, age, marital status, vereran status, gender identity or expression, or sexual orientation.

**Proposed:** 1.109 The Tau Beta Sigma Sorority neither approves of nor is responsible for actions of members of local chapters (commonly referred to as "hazing") which may result in injury to persons or damage to property. Hazing is defined as any action taken or situation created, intentionally or through negligence, to produce mental or physical discomfort, embarrassment, harassment, or ridicule.

1.110 The Tau Beta Sigma Sorority expressly prohibits discrimination by any component part of the Sorority or by any person acting on behalf of the organizations on the basis of race, ethnicity, color, national origin, sex, ability status, reliegion, age, marital status, vereran status, gender identity or expression, or sexual orientation.

**Rationale:** This mirrors the old policy language and is inappropriate to be in the National Constitution per the recommendations of our insurers.

d. 2.101

**Current:** 2.101 The Corporation shall have jurisdiction over all component parts of the Sorority and shall represent them and approve all decisions in matters of National Policy, alumni, public relationship, legal action, and controversy which may be referred to its Board of Trustees by the National Chapter or National Council. The decision of the Board of Trustees shall be final in all cases.

**Proposed:** 2.101 The Corporation shall have jurisdiction over all component parts of the Sorority and shall represent them and approve all decisions in matters of National Policy, alumni, public relationship, legal action, and controversy which may be referred to its Board of Trustees by the National Chapter or **the** National Council, **or the Tau Beta Sigma Alumni Association Executive Council**. The decision of the Board of Trustees shall be final in all cases.

**Rationale:** Reflects current practice and is an important legal distinction. Also provides consistency.

#### e. 2.104

**Current:** Mrs. Janet West Miller, past National President, shall be a permanent honorary member of the Board of Trustees of the Sorority, but shall not have a vote on the Board.

**Proposed:** Mrs. Janet West Miller, past National President, shall be a permanent honorary member of the Board of Trustees of the Sorority, but shall not have a vote on the Board.

Rationale: Janet has, sadly, passed away.

#### f. 3.801

**Current:** A report of the activities conducted during the biennium shall be submitted by each National Officer, the Board of Trustees Chair, each District President, and the National Chapter Field Representative at each regularly called Convention of the National Chapter. Each Chairperson of a Standing or Special Committee shall submit a report of the activities of the Committee, together with the Committee's recommendations, at each convention of the National Chapter. All reports shall be typewritten and submitted in hard copy to the National President and National Vice President for Communication and Recognition. An additional copy shall be submitted via electronic format to the National Vice President for Communication. One copy of all reports shall be filed at the National Headquarters by the National Executive Director.

**Proposed:** A report of the activities conducted during the biennium shall be submitted by each National Officer, the Board of Trustees Chair, **and** each District President, <del>and the National Chapter Field Representative</del> at each regularly called Convention of the National Chapter. Each Chairperson of a Standing or Special Committee shall submit a report of the activities of the Committee, together with the Committee's recommendations, at each convention of the National Chapter. All reports shall be typewritten and submitted in hard copy electronically to the National President, the National Vice President for Communication and Recognition, and the National Executive Director. An additional copy shall be submitted via electronic format to the National Vice President for Communication and Recognition. One copy of all reports shall be filed at the National Headquarters by the National Executive Director.

**Rationale:** We do not have a Chapter Field Representative. Other changes focus on what aligns with current practice of the organization and any grammar issues.

#### g. 5.402

**Current:** Each District Officer shall be at least a sophomore student and an Active member of the Sorority in good standing, at the time of election. Officers elected during their final year of college may serve out their current term of office, provided that a complete Life Membership application, including all fees, is filed with National Headquarters prior to the student's graduation. Each District Officer shall have exceptional business or professional ability and shall be capable of representing the

Sorority and District when called upon to do so. Each District Officer shall have the best interest of the Sorority at heart and be willing and able to devote the necessary time to execution of the duties imposed by the office and shall be actively participating in or serving bands during their term of office. All District officers shall serve without compensation.

**Proposed:** Each District Officer shall be at least a sophomore student, **as defined by the student's college or university**, and an Active member of the Sorority in good standing, at the time of election. Officers elected during their final year of college may serve out their current term of office, provided that a complete Life Membership application, including all fees, is filed with National Headquarters prior to the student's graduation. Each District Officer shall have exceptional business <del>or</del> **and** professional ability and shall be capable of representing the Sorority and District when called upon to do so. Each District Officer shall have the best interest of the Sorority at heart and be willing and able to devote the necessary time to execution of the duties imposed by the office and shall be actively participating in or serving bands during their term of office. All District officers shall serve without compensation.

**Rationale:** The first change added for clarity of the sophomore student status. Secondly, a District Officer should have both exceptional business and professional abilities.

h. 5.404

**Current:** The District President shall preside at all meetings of the District and shall be a nonvoting member of all District Committees, with the exception of the Nominations Committee which they shall appoint, and shall render all possible assistance to the District Counselor. In the absence of the District Counselor, the District President may be designated as the official rep representative of the District whenever such representation shall be required.

**Proposed:** The District President shall preside at all meetings of the District and shall be a nonvoting member of all District Committees, with the exception of the Nominations Committee which they shall appoint, and shall render all possible assistance to the District Counselor. In the absence of the District Counselor, the District President may be designated as the official rep representative of the District whenever such representation shall be required.

#### Rationale: Repetitive

*i.* 5.902

**Current:** A report of the activities of the office held shall be submitted in triplicate by each District Delegate at regularly called National Conventions.

**Proposed:** A report of the activities of the office held shall be submitted in triplicate by each District Delegate at regularly called National Conventions.

Rationale: This is not our current practice.

j. 5.601

**Current:** A regularly called meeting of the District shall be held on a yearly basis. The exact date is to be determined by the host chapter subject to the approval of the majority of the District Counselor and Governors. In the absence of a decision by the close of the District Convention, the District Counselor and Governors will determine the location for the next convention.

**Proposed:** A regularly called meeting of the District shall be held on a yearly basis. The exact date is to be determined by the host chapter subject to the approval of the majority of the District Counselor and Governors. In the absence of a decision by the close of the District Convention, the District Counselor and Governors will determine the location for the next convention. The District Counselors and Governors will determine the location for the next convention. The District Convention in conjunction with the National Headquarters and the National Presidents.

Rationale: This reflects the current practice of the organization.

*k.* 6.201

**Current:** The officers of a chapter shall be: President, Vice President, Secretary, and Treasurer, or other officers as deemed necessary by the individual chapter.

**Proposed:** The officers of a chapter shall be: President, Vice President **of Membership**, Secretary, and Treasurer, and other officers as deemed necessary by the individual chapter.

Rationale: To reflect current practice.

*l.* 6.606

**Current:** ASSOCIATE. Associate Membership is granted to a member of Kappa Kappa Psi who transfers to a college or university which does not have an Active Kappa Kappa Psi chapter. The member must meet the requirements as defined in the present transfer policy. Before becoming eligible for Associate Membership, the potential Associate member must be educated in the Ritual and traditions of Tau Beta Sigma. Associate members have all of the rights, privileges, duties, and responsibilities of Active members. Any exceptions must be approved by the National Council. **Proposed:** ASSOCIATE. Associate Membership is granted to a member of Kappa Kappa Psi who transfers to a college or university which does not have an Active Kappa Kappa Psi chapter. The member must meet the requirements as defined in the present transfer policy **6.622**. Before becoming eligible for Associate Membership, the potential Associate member must be educated in the Ritual, **operations**, and traditions of Tau Beta Sigma. Associate members have all of the rights, privileges, duties, and responsibilities of Active members. Any exceptions must be approved by the National Council.

Rationale: We do not have a transfer policy, and this reflects current practice.

m. Changing of Language

Proposed: Change all mentions of the National Vice President for Colonization &
Membership in the National Constitution to National Vice President for Membership
& Expansion. Change all mentions of Colony in the National Constitution to
Petitioning Group.

**Rationale:** To make Tau Beta Sigma more inclusive and welcoming by removing language with negative connotations.

n. 3.304

**Current:** Between conventions, the financial policies of the National Chapter shall be governed by a seventy-five (75) percent favorable vote of the National Council.

**Proposed:** Between conventions, the financial policies of the National Chapter shall be governed by a seventy-five (75) percent favorable vote of the National Council. The National Council may also implement a biannual increase in initiate fees and membership dues to not exceed five (5) dollars at the beginning of each biennium with a seventy-five (75) percent favorable vote of the National Council. Any increase in excess of five (5) dollars must be voted on by the National Delegation by simple majority.

**Rationale:** Our current practice involves having the national delegation vote at every National Convention for any dues increases. Having the option to increase \$5 allows the National Council more flexibility to manage the operational finances of the sorority amid rising costs of insurance and general rationale.

When reviewing the District and Chapter Budget Templates, the committee formulated a list of things such as spelling changes or formatting issues that can be looked at. These include:

- Having colors that contrast instead of complement for ease of reading
- Create autofill equations for calculations
- Make the colorization consistent on each template

- Look into other templates, such as a ledger template
- Consistent Column Titles
- Consider a Freezing titles option for the template
- Increase the font size for the headers in the Chapter Budget Template
- Check both templates for any spelling errors
- Check all formatting to make sure the sizing is appropriate

- 2. Review the Constitution and make sure it reflects the current business practices of the sorority

#### **APPENDIX O: Report of the History & Traditions/Ritual & Regalia Committee**

The 2021 History & Traditions/Ritual & Regalia Committee was charged with the following:

- 1. Review the report of the 2019 History, Traditions/ Ritual, and Regalia Committee.
- 2. Review the Tau Beta Sigma Loyalty Song, and make recommendations for changes to the phrase "God grant us strength to be" in the song.
- 3. Review the report of the 2019-2021 History and Archives Committee
- 4. Review the list of "<u>Major Moments in Tau Beta Sigma History</u>" as compiled by the Tau Beta Sigma History and Archives Committee, and discuss additional topics that you all would like to learn about. Within this list provided, sort the items in order of importance/desire to learn these topics.
- 5. Review the Ritual accessibility guide provided by the DEIA committee.

This committee met twice over the course of the 2021 National Convention. Our discussion primarily concerned the removal of religious affiliation from Tau Beta Sigma's Loyalty Song (see following recommendation), as charged by the National Council. The 2021 Committee was largely in favor of this change, especially given the recent, related change to our ritual, and our suggested lyrical edit was the result of much collaboration. During our first meeting, we reviewed the charges from the 2019 Committee and the National Council and attached documents, and discussed the contents of and proposed additions to the "Major Moments in Tau Beta Sigma History" compilation. At our second committee meeting, we reviewed the DEIA Ritual Accessibility Guide and discussed its necessity to an inclusive ritual experience, as well as potential edits, additions, and stipulations. During this meeting, we also revisited the Major Moments in Tau Beta Sigma History, discussing our organization's top research priorities. Finally, the Committee compiled a list of suggested changes to the Loyalty Song, searching for substitutes to religiously connotated lyrics, especially the reference to "God". After reviewing suggestions with the committee members, we would like to recommend the following lyrical edit to the Loyalty Song:

#### **Proposed Change:**

Current: God grant us strength to be/Renewed to join with thee.

Proposed: We have the strength to be/And fortitude to serve and lead.

<u>Rationale</u>: We hope that, in removing allusion to any one belief system, we reduce the risk of alienating our current or potential members. Substituting the reference to "God", as well as replacing religiously connotated vocabulary like "renewed", offers us the chance to emphasize our member's dedication to Tau Beta Sigma's vision over any aspect of their private lives. Ultimately, our aim is toward inclusivity.

"The strength to be" refers to the courage and skill our sisters demonstrate unconditionally; Tau Beta Sigma has the strength to exist, encompassing our values, goals, and morals, in all settings. The reference to "fortitude" aligns with our new perception of our founding purpose, also referenced: "to serve and lead".

The Committee charges the 2023 History & Traditions/Ritual & Regalia Committee with the following:

1. Review the report of the 2021 History & Traditions/Ritual & Regalia Committee.

- 2. Review the report of the 2021-2023 History & Archives Committee.
  - a. If applicable: Review the History & Archives Committee's research on the history and significance of the Turtle to Tau Beta Sigma on a district and national level.
  - b. If applicable: Review the History & Archives Committee's recommendation as to whether the Turtle's significance should be taught and emphasized throughout our organization, and to what extent.

The Committee charges the National Curriculum Committee with the following:

- 1. Consider adding more information about the history, experience, and significance of Black sisters and HBCUs (historically Black colleges and universities) in our organization within the Overture curriculum.
  - a. This information would include, but not be limited to:
    - i. The first Tau Beta Sigma chapter at a HBCU, Beta Omicron, and its founding officers.
    - ii. The first Black active member(s), District Officers, National Officers, and executive staff members of Tau Beta Sigma.

The Committee charges the 2021-2023 History & Archives Committee and the National Council with the following:

- 1. Review the additions to the Major Moments in Tau Beta Sigma History list and finalize rankings of importance.
- 2. Research and compile the history and significance of the Turtle to Tau Beta Sigma on a district and national level.
  - a. Determine whether a) further education of the Turtle's significance would be beneficial to the Sorority, b) the Turtle is a suitable candidate for an officially recognized National symbol and/or mascot, or both.
- 3. If and when applicable, archive the previous version of the Loyalty Song.

The Committee charges the DEIA Committee with the following:

- 1. Review the History & Traditions/Ritual & Regalia Committee's suggestions and concerns regarding the ritual accessibility guide, implementing relevant updates to the most appropriate extent.
  - a. The Committee's suggestions and concerns include the following:
    - i. Advise chapters to contact their schools' Accessibility Services for further, more specific guidance.

- ii. Advise chapters on the most appropriate way to determine the length of time/distance spent walking, standing, etc. during ritual.
- iii. Suggest when and how chapters should ask their members whether they require accommodations for sorority activities (ritual or otherwise), and how to do so most appropriately and respectfully.
  - 1. Advise how to most appropriately "check in" with sisters (i.e., "has anything changed since the last time you were asked?")
- iv. Advise chapters on matters of confidentiality with regard to requests for accommodations.

On behalf of our committee, we would like to thank the National Council for allowing us the

opportunity to serve this committee and the organization in this way. As the Chairs of this

committee, we would like to thank all of our committee members for their very productive

dialogue and new ideas throughout the week. To our Advisors, thank you for being supportive

and readily available for the two chairs of the committee, as well as the entire committee.

#### **APPENDIX P: Report of the National President**

My Dear Sisters and Brothers of Tau Beta Sigma,

Two years ago, I stood before the delegation and gave my president's vision for our 2019-2021 biennium. I discussed the need for our organization to take a moment to collect all of the wonderful projects that we tirelessly developed and worked on over the last several years and solidify them. Streamline them. Take the time to make sure the curriculum and the programs of the Sorority, the operating procedures of our national leadership team and of our NHQ staff, and all of the other pieces of our organization along the way are defined, strong foundations for the future. Here's a passage of that vision...

Moving into this next biennium, taking into consideration our 75th Anniversary in 2021, I think that it's extremely important to reflect on our history. The foundation laid before us in 1946 is, at its core, strong and unwavering. Throughout the past 75 years, we have used that foundation as a springboard for ideas, for initiatives, for programming, and for policies to make our Sorority greater and grander, taking us through wonderful periods of growth. In fact, if we take a look at the past several years, it is easy to see that we have

experienced a time of expansion in many ways: More national programs, a chapter visitation program, expanded resources, a standardized national curriculum. Resources and activities that enhance our ideals and purposes and make Tau Beta Sigma better and stronger than ever.

When I think of my vision for Tau Beta Sigma, of what I want to see for our organization in the next 2, 5, 10, 75 years, it's simple: I want us to do TBSigma and do it well. And I think that in order to do that we need to take a hard look inward to see where we excel and where we have areas of improvement. As a National Leadership Team, we need to take the time to re-evaluate our new practices, programming, curriculum to make sure that we are providing you with the best National structure and resources possible. At the same, we need to ask chapters to take an internal look – is your chapter living up to the ideals and purposes of Tau Beta Sigma? Does your chapter have the best practices and programming in place to serve your bands and to ensure the longevity of Tau Beta Sigma on your campus?

Well, this biennium had its own plans for all of us as individuals as well as our organization, didn't it?

Fortitude and courage to see an ideal, to seize upon it, and to follow it wherever it may lead you in Tau Beta Sigma... Fortitude and Courage. These words became our guiding principles more than ever this biennium as our organization faced several challenges, many without precedent. The spirit of our members, combined with the solidity of our past, provided positivity and determination in the face of great trial. The National Leadership Team worked hard to ensure that despite the many hurdles in our path, Tau Beta Sigma would endure and thrive. From our members to our alumni to our leadership team members, we rose to the occasion, charting a new course and learning from one another through a global pandemic, racial and civil unrest, the death of a Sorority matriarch, and adapting to a fully virtual format for chapter operations, district events, and national programs. All of our members have met adversity head-on, having the fortitude and perseverance needed to carry on for greater bands, and to push Tau Beta Sigma forward in many wonderful ways.

Here are some of the ways in which we carried on For Greater Bands in the face of COVID-19:

- Our Active membership numbers remained strong. Between the Fall of 2019 (prepandemic) and the Fall of 2020 (mid-pandemic) the difference in number of members listed as Active, Conditional, and Associate on each Chapter Personnel Report was negligible.
- Alongside Kappa Kappa Psi, we created a Health and Safety Team in an effort to collect data from each of our chapters' schools and to answer questions our members had as they navigated through the uncertainty of 2020.
- We also created a virtual chapter operations document called *Pivot*! as well as chapter guidance regarding how to participate in our national programs in a virtual environment.
- Our District Counselors and District Officers successfully navigated two seasons of virtual District Conventions.

• We financially contributed to the Performing Arts Aerosol Study in an effort to support our students, our band programs, and our music community through this unprecedented time.

In addition to those pieces directly related to the pandemic, we also had the opportunity to move the Sorority forward in several ways:

We made a commitment to address the diversity, equality, inclusiveness, and accessibility within Tau Beta Sigma through the formation of a DEIA committee as well as via a partnership with our peer organizations in the Professional Fraternity Association. This partnership gives Tau Beta Sigma access to larger DEIA initiatives and a professional DEIA consultant. In addition, plans to address accessibility issues within Stillwater Station have been initiated and will continue into the next biennium.

- Tau Beta Sigma and Kappa Kappa Psi jointly contracted with a consultant from Nonprofit HR. This provided the opportunity for someone outside of our organizations to take a critical look at our documentation and processes in order to provide feedback and propose necessary changes. We were especially grateful for their assistance in helping develop work-from-home protocols due to the global pandemic.
- We invested in the future of our organization and our Headquarters staff by adding a second office building to our assets. This proved to be especially beneficial as distancing for our headquarters staff became a necessity. Our two properties now enable the organization greater flexibility to host meetings and other events on-site in Stillwater, providing long-term cost-savings.
- Tau Beta Sigma and Kappa Kappa Psi partnered with Salesforce to make vital upgrades to our IT infrastructure to provide our members, leadership and staff with improved database, reporting, financial, and communication tools through the OMRS 2.0 project.
- Updating our documents and resources was of the utmost importance this biennium. Some of this work included: updating our petitioning group handbook to provide thorough guidance on current chapter standards and all steps needed for chapter activation; creating a handbook for the Chapter Visitation Assistants; refreshing our guidance and resources for the District Counselors; overhauling our Chapter Operations Handbook; updating the Ritual Workbook to reflect changes from the 2019 National Convention; fand revising/establishing several Standard Operating Procedure Documents for our volunteer leadership and our National Headquarters staff.
- We welcomed a new staff member to National Headquarters, as Lisa Croston became our first-ever National Events Coordinator. The creation of this position has allowed Tau Beta Sigma, in conjunction with Kappa Kappa Psi, to standardize and centralize our District Convention site selection, registration, and payment processes through our National Headquarters Staff, mitigating long-standing financial and logistical concerns

associated with our District Conventions.

- One of our focuses this biennium was risk management, as our insurance company asked us, along with Kappa Kappa Psi, to update our Risk Management Policies to align with current industry standards. During the updating process, we recognized the need to advance and diversify our Risk Management Team in an effort to further develop our hazing prevention education plans and hazing investigation procedures. Working with our partners at CAMPUSPEAK & Dyad Strategies ® who are leaders in the hazing prevention, education, and investigation field, the Sorority certified 12 of our National Leadership Team members and two of our NHQ staff members as Hazing Investigators. Eight of those National Leadership Team members are also certified as Hazing Prevention Educators.
- The Chapter Visitation Program continued to grow in depth and focus, despite the pandemic. Every chapter of Tau Beta Sigma received one-on-one time with a member from the National Leadership Team at some point during the biennium, focusing on topics relevant and relatable to that specific chapter. Additionally, our Chapter Visitation Assistants and Counselors were invaluable in assisting the National Leadership Team with communication initiatives and were able to provide more hands-on guidance as chapters navigated the uncertainty and ever-changing nature of this biennium.

As your National President, I felt extreme imposter syndrome off and on during the biennium as we navigated all of the curve balls thrown at us. I wondered if I was really the best person to help the Sorority navigate through these rough waters or if there was another, better option. I wondered how I could possibly inspire our students, our volunteer leaders, and our staff members to be strong when I felt weak and broken. I wondered if I could give everything to the Sorority that it needed without neglecting my family, especially my mom who had just moved to Kearney to be with us and my children who were both home with mom and dad every day as we tried to continue working as normally as possible.

When I felt this way, I tried to lean in, just as I was asking each of you to do. I leaned into our 8 and 5 and the Ritual. I leaned into my family and faith. I leaned into our Chapter Visitation Assistants and our Counselors. I leaned into the National Council, the Board of Trustees, and the TBSAA Executive Committee. I leaned into our past national leaders and dignitaries. I also came across a passage during the early days of the pandemic and taped to my computer for any time I needed a reminder of what I needed to do in order to be the leader I thought Tau Beta Sigma needed. I'll share the end of it with you now because I think it's poignant for any and all of us who suffer from imposter syndrome and self-doubt and self-judgement.

# Your story is not over, and the future is still open. Get up. Go again. Do your damn best today. Free yourself from the judgement. One more step forward in faith and courage.

Take another step. Go in faith and in courage. Have Fortitude. Do your best. That's all any of us can do, and I can say with certainty that it's easier when you are surrounded with those who love

and support you through it all. I was surrounded by and leaned into the best of the best, and I want to take a few moments to publicly thank them for all they did to help me and to help Tau Beta Sigma this biennium:

To Past National Leaders of Tau Beta Sigma - Thank you for your service and sacrifices to Tau Beta Sigma. Your tireless efforts laid a strong foundation for our organization, driving us to our 75<sup>th</sup> anniversary and all of the successes we have seen this biennium. We are forever in your debt.

To The 2019-2021 District Officers, especially the District Presidents – Each of you will always hold a special place in my heart. You were asked to lead your peers during one of the most difficult periods of our Sorority's history and of your bands' and schools' histories. Yet, you never wavered. And even though you had to shoulder many hardships, you were always thoughtful, flexible, and ready to roll with each change that came our way. Thank you for your service to Tau Beta Sigma – every Sister and Brother is better because of your leadership!

To Our NHQ Staff – Thank you, thank you, thank you. You each worked so very hard to keep the Sorority running through the hardships and unexpected nature of this biennium, going above and beyond in many instances for the betterment of our organization and members. Because of your unwavering dedication to our students and volunteers, Tau Beta Sigma was able to persevere through the pandemic, making it here today!

To Our Chapter Visitation Assistants and District Counselors – Similar to our National Headquarters Staff, we would not have made it through all that this biennium threw at us without the compassion and dedication you showed to our students and other volunteer leaders.
