Appendix A: Standing Rules for the National Convention

The Standing Rules for Tau Beta Sigma National Convention are as follows:

- 1) All business sessions shall begin promptly at the place and hour specified on the Convention Program, unless otherwise stated by the meeting chairperson.
- 2) All reports shall be submitted electronically to the NVPCR prior to presentation, unless otherwise specified by the NVPCR.
- Reports of committees that would change the Constitution must be referred to the Jurisdiction Committee for review and approval before presentation to the floor.
- 4) Any member desiring the floor shall rise, state clearly their name and the name of the Chapter which they represent (either as a delegate or proxy).
- 5) The chair, at their discretion, may recognize individuals other than the delegates and proxies who wish to discuss a motion on the floor. Those individuals are subject to the same frequency and time restrictions as delegates and proxies.
- No one, other than a member of the National Council, shall speak more than twice during the same session to the same question, and not longer than three minutes at one time without permission of the Convention. The question of granting permission shall be decided by a two-thirds vote without debate.

Appendix C: Report of the DEIA Committee

Sisters of Tau Beta Sigma,

I want to begin this report with a land acknowledgment recognizing the ancestral homelands of the Shawnee, Cherokee, and Chickasaw nations that we have been occupying and doing our work on this week here in Lexington. I also want to acknowledge all the pain people may be experiencing as it relates to the attacks on diversity, equity, inclusion in multiple states across the nation. We are in an uncertain time, which means it is important now more than ever to engage with a supportive community across shared values.

The 2023-2025 Biennium DEIA Committee was charged with the following:

- 1. Review the report of the 2021-2023 DEIA Committee
- 2. Develop resources for members to understand the DEIA issues they face.
- 3. Organize and investigate the DEIA challenges that the sorority is facing.
- 4. Work collaboratively with other appropriate TBS Committees on DEIA specific items.
- 5. Develop resources and programming that helps chapters identify areas to increase inclusivity within their bands and chapters.
- 6. Continue developing a proposal for a DEIA Vanguard Award to honor work done by individuals, chapters, and band programs.
- 7. Collaborate with the KKPsi DEIA Committee on joint projects, to include inclusive recruitment guidelines

This was the third biennium of operations for the DEIA Committee. We were formed in 2020 by our 38th National President, Adrienne Rall, in response to the national unrest and conversations sparked by the murder of George Floyd, Ahmaud Arbery, Breonna Taylor, and countless others in 2020. To quote the Statement of Solidarity released around the same time, "We are being confronted by a crisis that needs to be recognized, racial violence, which has permeated our country for years and left us scared, angry and frustrated. [...] The National Leadership Teams will work to continue conversations and programming surrounding diversity and inclusion to reinforce and strengthen environments that align with our values and purposes." Since 2020, we have unfortunately endured many other crises, including the rise of anti-Asian American and Pacific Islander (AAPI) hate, Anti-Semitism, attacks on women's reproductive rights, anti-Trans legislation, continued economic disparities, and even legislative attacks on diversity, equity, and inclusion itself. Despite this discord, the DEIA Committee has marched forward with fortitude and courage to ensure that the Sorority remains a pocket of greatness even with global challenges. For additional history and to review 2021-2023 Committee highlights, feel free to review the Committee Report submitted as part of the 2023 National Convention Minutes.

Following National Convention in 2023, the DEIA Committee was appointed for the 2023-2025 Biennium and began our work. We have had five at-large committee meetings with several other smaller project group meetings in between. This year, the major projects we have worked on include:

- Student and NLT Outreach
- DEIA Landing Page
- DEIA Workshop Outline
- DEIA Vanguard Award
- District Convention Accessibility Standard Operating Procedures
- Programming at District and National Conventions
- Legacy Plan

Student and NLT Outreach

The <u>deia@tbsigma.org</u> email received several emails from our student membership with partnership opportunities. The Midwest District organized a series of events dedicated to discussing and exploring DEIA as part of the MWD Lyrce Piece project. The Northeast District organized a DEIA Panel for their NEDTalks series and incorporated DEIA lessons and activities into their Fermata: Continuing Membership Education program. Thank you to Lyric and Julia for working with the NED on this initiative. The Zeta Omicron Chapter reached out to the committee for a DEIA workshop. The workshop covered how DEIA relates to TBS and the 5&8. Thank you to Kat, Clara, and Lyric for working with ZO. During the 2024 District Convention Season, the Southeast and Southwest Districts invited DEIA Committee members to present workshops. Thank you to Caleb (view a copy here) and Jon for presenting. We are grateful for student enthusiasm for and commitment to DEIA work and how you all operationalize our values.

The Chapter Visitation Associates invited the committee to facilitate a DEIA training for CVAs. The training, led by Caleb, consisted of talking through scenarios of DEIA-related chapter challenges that CVAs may encounter in chapter visits (view a copy here). The National Vice President for Membership and Expansion Allison Leeman invited the DEIA Committee to facilitate a DEIA workshop at National Leadership Conference. The workshop, presented by Caleb and Julia, discussed items to include cultural humility and inclusivity, and practical strategies for fostering a diverse and inclusive environment (view a copy here). Thank you to NLT members for prioritizing DEIA in national leadership team professional development opportunities.

DEIA Landing Page

At National Convention in 2023, the Sorority unveiled the DEIA Landing Page. The website was very bare bones, and included information about the DEIA Statement, a Meeting Accessibility document, a link to the Advocacy resources page, and a DEIA in TBS History timeline. Committee members Clara, Julia, Ashlyn Cobb, Natalie Kimura, and Caleb worked on further develop the website to make it an even better resource for our members. The updated website went live last summer on tbsigma.org/deia. We hope the website will continue to serve as a hub of resources for members and that it will be constantly updated for new information. Thank you to National Vice President for Communication and Recognition Kelsey Reilly, and National Projects & Systems Manager Aaron Moore at the National Headquarters for your assistance in updating the landing page.

DEIA Workshop Outline

40th National President Siobhan Wilkes Bratcher charged the committee with developing a DEIA- centric workshop(s) to be used within the sorority. Committee members Caleb, Julia, Catherine Brown, and Natalie developed an outline and activities. See the facilitation guide here.

DEIA Vanguard Award

In the leadup to the 2023 National Convention, the Committee was working on a recognition program to honor individuals, chapters, and band programs who work towards addressing diversity, equity, inclusion, and accessibility ideals. We named this recognition program the DEIA Vanguard Award Program upon suggestion from then-National President Erika Pope. We got as far as creating the general structure at that time, but progress stalled and development was moved to the second half of this biennium. Committee members Dominic Gattozzi, Julia, and Caleb worked on an <u>award proposal</u>, which was approved by the National Council. The award program consists of the following categories:

- Band Achievement
- Chapter Achievement
- Individual Achievement Collegiate
- Individual Achievement Professional
- Local Alumni Association Achievement

We developed criteria, an application, and selection process, and recipients will be announced during Banquet ad District and National Convention. We are excited at the potential of this program to advance our mission statement: to promote equality and diversity and look forward to implementing this program in the next year with the National Council. Be on the lookout for the application!

District Convention Accessibility Standard Operating Procedures

Following accessibility concerns during the 2024 District Convention season, it was suggested to expand the Meeting Accessibility Document we had (available on tbsigma.org/deia) to create a more robust document for district convention planning. The committee has sourced ideas and drafted a Standard Operating Procedure, which was approved by National President Leslie Gartin and forwarded to the Event Coordinator. We did not hear about any accessibility issues during the 2025 District Convention season, and look forward to working with the district and national leadership teams to ensure we are planning accessible events that all our members can engage with.

During the conversation, T'Chaka asserts "A man who has not prepared his children for his own death has failed as a father." While morbid, this concept can be applied to leadership. A leader who has not prepared their successors to assume the mantle of leadership has failed. To this end, the Committee developed a <u>Legacy Plan</u> to be used by the next biennium's committee as a strategic guide.

Conclusion

I want to conclude this report with encouragement for how you all can be involved in the work of the DEIA Committee. We are hungry for your collaboration. If you want to partner with the committee for education or just to bounce ideas off of, please do not hesitate to reach out at DEIA@tbsigma.org. We are in a very difficult time as it relates to being able to practice diversity, equity, and inclusion. Many colleges and universities across the nation are being forced to shut down their DEI offices, which limits the resources you have available. Our hope is that

we as a committee and sorority can be a shining light in embodying our shared values and mission to promote equality and diversity.

I want to express my sincere thanks and gratitude to our 41st National President Leslie Gartin, for your continued support of the work of the committee. It's critical to have support from the top. Thank you, Leslie!

Appendix D: Biennial Report of the Tau Beta Sigma Board of Trustees

The Board of Trustees is composed of six elected members, the Immediate Past President, and the National President to ensure the corporation's success. The Board of Trustees defines strategic and organizational structure, monitors operations and facilities, and ensures that the organization complies with all applicable laws, rules, and regulations.

Activities and Oversight

As the Sorority navigated significant transitions, the Board of Trustees stepped into expanded roles to maintain Sorority operations and fulfill our constitutional responsibilities. We focused on advancing our organizational capabilities and strengthening key partnerships throughout the biennium.

This commitment was demonstrated through the joint appointment of Dollie O'Neill as Interim National Executive Director by the Sorority and Fraternity. The Board worked to align initiatives with both the National Council and the Tau Beta Sigma Alumni Association (TBSAA), reinforcing a spirit of collaboration across all levels of the Sorority's National leadership. This collaborative approach included providing support and maintaining a strong presence at all District Conventions, assisting the National Vice President for Membership & Expansion in launching an Expansion Committee to develop growth strategies and identify new chapter opportunities, offering Trustee representation on all National Committees, and serving as installing officers for newly established chapters.

We also continued to champion the development of OPUS, our new online membership system, as part of our commitment to support innovation and organizational efficiency. In addition, the joint efforts of the Assessment and Finance Committees enabled strategic tracking of membership trends and informed the development of the 2025–2027 biennium budget.

Financial Governance

A core responsibility of the Board of Trustees includes overseeing capital development and managing the Sorority's investments. The Trust Accounts increased in net value by over \$115,000 during the biennium and some of this growth can be attributed to our Capital Development Committee successfully executing two #GivingTuesday campaigns in 2023 and 2024.

Our Giving Tuesday campaigns remain crucial avenues for engaging with new donors and reconnecting Alumni members with the Sorority.

The committee also initiated a soft launch of the Sorority's 80th Anniversary Campaign and are actively preparing to engage all of our stakeholders in promoting the goals of the campaign during the 2025 National Convention. Preparations have included expanding our donor giving levels to provide recognition for higher donor contributions, forming an Anniversary Committee to assist with campaign efforts, and developing marketing materials for maximum engagement.

Additionally, Trust endowments funded \$16,000 in scholarships to Active members, Women in Music Speakers at District and National Conventions, development costs for OPUS, and a reception, co sponsored with TBSAA, at The Midwest Clinic.

Greetings Sisters and Brothers of Tau Beta Sigma,

As this biennium draws to a close, we're filled with pride for what we, the active alumni of the $TB\Sigma AA$, built together, step by step, note by note. This era of intentional connection, meaningful engagement, and substantial service has shown us that when alumni harmonize around a shared vision, powerful things happen.

At the start of the biennium, the three branches of the Tau Beta Sigma Leadership Team launched a ten-year strategic plan grounded in the Sorority's revised Vision Statement. Each branch identified key priorities to sustain a vibrant and connected membership. In support of this effort,

the TB Σ AA Executive Council adopted five objectives that directly align with our vision of **connection, engagement, and service**:

- Enhance the Alumni Experience through Recognition and Collaboration
- Ensure Membership Growth & Retention
- Engage Alumni through Service & Philanthropy
- Support a Meaningful LAA Experience
- Provide Resources to Connect Members as Sisters, Professionals, and More

Guided by the Sorority's strategic plan, the Alumni Association objectives, and a shared goal for an engaged membership and thriving organization, the Tau Beta Sigma Alumni Association (TB Σ AA) Executive Council is proud to share how we've brought our goals to life and what lies ahead.

Alumni Experience through Recognition and Collaboration

This biennium was a harmonious celebration of alumni life. From social media takeovers to milestone highlights and recognition awards, we worked to uplift the individual stories that make our community strong. TB Σ AA celebrated alumni through birthday shoutouts and personal and professional achievements of members with Alumni Notes. We will honor the exemplary service and leadership of a member through the **Sue Robash Carr Distinguished Alumni Award** during the 2025 National Convention Banquet. Our Finance Director, Tyra Yiare-Hollway, and her committee led the work of providing more than \$7,000 in direct support to alumni, including **six graduate school** scholarships and **two grants** that funded alumni-led music projects advancing the Tau Beta Sigma mission.

We also introduced new merchandise and official $TB\Sigma AA$ jewelry to serve as emblems of pride and connection for those continuing the journey beyond college. Executive Council members traveled across the country to attend each District Conventions during the biennium to connect with alumni, support LAA leaders, and build national relationships. Each shoutout, spotlight, and takeover helped reinforce our most important message: alumni matter.

Membership Growth & Retention

The alumni journey continues beyond graduation, and our commitment to develop and sustain this melodic network should also persist. Over the past two years, under the leadership of David Alexander, Vice Chairperson and Communications Director, and his committee, we have organized numerous national virtual events to engage and connect with our members, including a special event recognizing our dedicated Gold Star Club members. Additionally, we have enhanced our outreach efforts through targeted emails and strategic messaging designed to reconnect with lapsed members and welcome new ones. This personalized renewal strategy and direct outreach have contributed to our growth and retention, with us ending the biennium with

600 active alumni members. Our membership tiers provide various levels of alumni engagement, and we are enthusiastic about building on this foundation. Moving forward, we are introducing a new membership tier aimed at making $TB\Sigma AA$ membership accessible to new graduates and enhancing benefits to support both value and visibility for all alumni.

Service & Philanthropy

Service remains a central theme in our alumni composition. In this biennium, $TB\Sigma AA$ alumni have actively engaged in volunteering, donating, and contributing back in impactful ways. Alumni gave generously during both Sorority Giving Tuesday campaigns and annual For Greater Bands Virtual 5Ks, which raised over \$4,000 to fund the $TB\Sigma AA$ Welcome Experience for NIB Participants. Our inaugural National Alumni Service Project united members to support a high school band auxiliary program managed by one of our alumni.

Five LAA Reimbursable Grants, totaling \$1,100, were allocated to Local Alumni Associations, fostering impactful, band-focused service initiatives nationwide, including projects such as a band career fair, music commissioning, collegiate band day, travel goodie bags for bands, and hydration supplies for bands participating in a community parade. The LAA service challenge encouraged LAAs to spearhead local initiatives, reinforcing the role of alumni in supporting community and collegiate bands. In the next biennium, we aim to expand these initiatives and further increase the service impact of our alumni members nationwide.

LAA Experience

Local Alumni Associations (LAAs) are the beating heart of alumni connection. We are ending this term with 16 TBSigma only and 9 Joint KKPsi & TBSigma LAAs. This biennium, through the support and guidance of the LAA Relations Director Jessica Smith, 9 LAA groups have made progress towards becoming approved LAAs, and we welcomed six new LAAs into our network, each offering a space for alumni to connect in their communities, continue service, and celebrate our shared sisterhood. We encouraged our LAAs to align their work to the goal of the Sorority and engage their members in meaningful ways through the LAA ACES Challenge. This program, which is like Focus on Five, began in 2022-2023, with 5 LAAs completing the inaugural challenge. Over the course of the biennium, 12 LAAs completed the challenge in 2023-2024 and 14 in 2024-2025. This biennium, LAAs led membership drives, hosted workshops and Women in Music events and social media campaigns and launched meaningful service projects. Every LAA contributed to our national harmony, and we aim to strengthen our infrastructure to support and sustain these local alumni connections.

Resources

Over the past biennium, enhancing access and visibility has been a priority for us. We have revamped the $TB\Sigma AA$ website and the monthly Entr'Acte Newsletter, expanded our Linktree,

strengthened our digital branding, and increased our presence on social media and in the Tau Beta Tuesday newsletter. Through the website, newsletters, targeted updates, and various resources, we ensured that alumni had the necessary tools and information to connect, engage, and serve. Moving forward, we will increase our presence on LinkedIn and commence curating historical TB Σ AA content to preserve and share our legacy.

Looking Forward

We are thankful to each of our members and supporters for their connection, engagement, and service. As we approach the 20th anniversary of TB Σ AA in 2027, our dedication to fostering a connected, engaged, and service-oriented alumni community remains steadfast. Appendix G: Report of the National Vice President for Communication & Recognition

To the National Delegation of Tau Beta Sigma,

The 2023-2025 biennium has been one of collaboration, intention, and renewed energy for me. From diving deeper into the responsibilities of the Vice President for Communication and Recognition to working alongside other National Leadership Team members, I've learned so much about how we can better amplify the voices of our members, celebrate excellence, and create systems that help our work flow more smoothly.

From introducing myself to new Secretaries/Treasurers to shaping consistent and celebratory content with the Communications Committee, each interaction has deepened my appreciation for this role and the impact our organization can make.

As I share this report with you, I hope to accomplish three things:

- 1. Provide an update on our progress in Communication and Recognition during this biennium,
- 2. Celebrate the people and chapters whose efforts have made a lasting mark, and
- 3. Encourage each of you to continue celebrating one another and seizing opportunities to grow and be recognized.

So let's get started.

COMMUNICATIONS AND SOCIAL MEDIA

My goals for the biennium were rooted in continuing the momentum of our predecessors—developing clear, professional communications, streamlining our processes, and celebrating our members' impact at every opportunity.

The Communications Committee has been a steady partner in this work. Under the leadership of Chairperson Misty Lovejoy, the committee met consistently to plan and execute thoughtful

campaigns. We established a new social media tracker to improve collaboration and streamline approvals through the National President.

Throughout the biennium, we rolled out campaigns for National Hazing Prevention Week, Giving Tuesday, and the 13 Days of Tau Beta Sigma, offering daily or hourly content to engage and inform our audience. The Women in Music campaign remained a pillar of our regular content strategy, highlighting powerful voices in music while spotlighting Tau Beta Sigma's mission in action.

Misty and I also met with each individual content team of the committee—graphics, copy, and research—to clarify expectations and improve our workflow. A small subcommittee reviewed and provided feedback on the 2020 social media policy to ensure our guidelines evolve with our platforms. Another team created a new video content guide, with TikTok in mind, to help us grow our presence and experiment with format and reach.

Over the past six months, our Facebook and Instagram metrics remained strong, with noticeable peaks in engagement during February and March as we promoted awards and convention season, and again at the end of June for the National Leadership Conference. Notably, our Juneteenth post and Focus On Five campaigns saw the highest reach on Instagram. While Facebook follower growth has slowed, Instagram has surged—boasting a **162.2% increase** in following during the second half of the biennium.

I also worked closely with Aaron Moore to align our content calendar with the National Observations Calendar, creating a strong rhythm of regular, mission-driven posts.

SCHOLARSHIP & RECOGNITION

This biennium, the Scholarship Committee received a record 49 applications—a significant increase from the last biennium thanks to the foundational work of the 2021-2023 VPCR. Thank you to Board of Trustee member Kris Wright, for her work on the committee. The committee will reconvene in the spring to plan for an even stronger outreach effort next year.





Appendix K: Report of the Assessment Committee

The 2023-2025 Biennium Assessment Committee was charged with the following:

- 1. Gather most recent versions of the following data: Paperwork, Focus on Five participation, 2023 National Convention Chapters seated, Chapter statuses, and any other data deemed appropriate.
- 2. Launch the second Biennial Climate Survey this fall to start adding the capability to detect trends amongst our members.
- 3. Maintain open communication lines with the National Council and Board of Trustees to provide data and support needed for ongoing initiatives.
- 4. Continue to analyze data and answer questions regarding facets of Tau Beta Sigma, pushing the Organization in a positive direction.
- 5. Incorporate new data collection processes and reporting with OPUS.
- 6. Identify stakeholders for key data areas and incorporate a regular cadence of updates for these individuals.
- 7. Identify and share relevant data and insights with members of the National Leadership Team and Active membership.

The Assessment Committee started off our biennium by successfully releasing the second Tau Beta Sigma Biennial Climate Survey in Fall of 2023. We used this survey to understand the general environment of our organization and our members' current experiences including attitudes around risk management and hazing, membership education, communications, and National Programs. We had 143 responses representing 48.5% of chapters. Thank you to those who participated. If you did not get a chance to participate, you will have another opportunity as we will be releasing the next Climate Survey this fall and encourage you to participate!

So what did we learn? Since this was our second survey, we were able to compare across the last two bienniums. General participation in National Programs and Chapter events is up, especially in Crescendo, For Greater Practice, and Coda. Confidence in accessing our membership reporting system is also up. OPUS was new for 2023 and appears to be making things easier for members.

We had asked a new question this biennium about whether members felt their presence, contributions, and/or opinions were valued. Not surprisingly, it was common for members to feel valued within their Chapter, and then feel less valued at the District and National levels. We hope to revisit this question within the survey this year. Additionally, we hope to continue to use subsequent Climate Surveys to help identify needs for additional resources or training, highlight our strengths to leverage within the organization, and to observe trends in membership over time.

One of the new areas the committee investigated this biennium was late fees: why they occur, how often it happens, etc. After reviewing, we were able to provide the National Council with recommendations regarding our late fee structure. Another new area for us this biennium was looking at VPM "success" - deemed to be when VPMs continue on to be Chapter President, become a Life Member, or become a District Officer. Less than 20% of VPMs continued on to be President of their Chapter, with this being the most likely of paths. With that said, rates have stayed fairly consistent over the past 13 years.

We continued to gather District Convention feedback this biennium. The information from these surveys such as concerns about dietary or other accommodations, important takeaways, and general feedback are taken back to each District Council in the hopes of being able to iterate and improve upon things for the next convention season. For the 2025 District Convention season, more communication frequently came up as an area of improvement, and members continue to enjoy attending conventions to build relationships and participate in the bigger sense of community.

Moving forward we would like to see the 2025-2027 Assessment Committee continue to be utilized to provide the data needed to drive decisions being made, and provide additional perspective. We will continue to look for ways to share knowledge gained with the larger organization.

Special thanks to the National Council for continuing to let us combine our passions of data and Tau Beta Sigma. Thank you to Allison Leemann, Sarah Griffith, Brian Main, Kathy Godwin, Lauren Funk, Jonathan Markowski, and newcomers, Allison Reagan and Jessica Smith for your unique perspectives on our organization, your excellent questions and discussion during our meetings, and the amazing data puns. This biennium would not have been successful without each of your contributions.

Appendix L: Report of the National Vice President for Membership & Expansion Members of Tau Beta Sigma,

What a biennium this has been! There have been twists and turns, new challenges, big laughs, and a whole lot of unexpected surprises and special moments since we last joined together in Orlando in 2023. In this final report, I aim to provide an overview of the efforts done this biennium in both my VPSP and VPME roles - and to share my thanks for all the Sisters who made our successes possible.

To begin, I want to share a highlight of the VPSP role. Coming into the new biennium I had two aims - update the Focus on Five Campaign and also expand our events and development offerings to be year-round. For the Focus on Five Campaign there were two changes: first, a shift in communication away from the Facebook group after receiving feedback from students that it wasn't regularly utilized and the second was a revision of our Stripe challenges to include leadership development as it is one of the core focuses of our Mission. Both of these changes were positive for student experience. While VPSP the National Council hosted four events including a Chapter Operations focused workshop day, virtual Women in Music Speaker Series, an evening to celebrate our band programs and performances from the Fall 2023 season, and finally a professional development and operations workshop day called Development and Transitions. These sessions were well-attended by both Active and Alumni members and created an opportunity to learn and connect with members from across the country outside of the Convention setting.

I'd like to take a moment to thank and highlight the Women in Music Speakers from 2023-2024. Each of these women shared their story including their inspirations and impact they hope to leave behind on those they connect with as musicians, leaders, and as people.

In March 2024 I transitioned into the role of NVPME. Coming into the role in the middle of Convention season and mid-way through a membership year I wanted to prioritize a few areas of effort to make hopefully the most impact with my time. I set out to strengthen our membership base with resources and a network of support, expand education resources and make Overture easier to implement for Member Educators, and begin strategic efforts to support our long-term expansion program. Through these areas of focus I wanted to also prioritize Chapter support, partnering with our DOBs/Sponsors, and refining processes where possible to make continued work easier for our volunteer leaders of the future. An experiential change in taking on the VPME role was transitioning in many ways from a front-line "doer" to instead being a connector and vision-setter for our volunteer and student leaders to take on new challenges and meet the needs of our Chapters and members.

This biennium the Curriculum Committee worked to further develop our membership education curricula Overture and Rondo. Thank you to the members of the Curriculum Committee for your work in furthering these resources and providing real-time support to our leaders and Chapters in implementing Member Education.

Main areas of progress for development of Overture included the following:

- We conducted an audit of Overture for Adult Learners led by Dr. Ted McCadden and in partnership with myself and the Committee Chairpersons Dr. Christopher Lukasik and Megan Enright. Through the audit we found opportunities to elevate learning objectives and bring DEIA concepts to more prominent spaces in the curriculum.
- Following feedback from Member Educators in recent years we transitioned the available Overture activities for Modules and Lessons to be in an easily updated online database. This was released as part of the 2025-2026 Overture content release in June. The Committee and incoming NVPME will continue to work this summer on adding new activity options based on Chapter submissions.
- And finally, last year we added additional resources and guidance to Overture for Chapters who utilize Presentation Shows or other celebrations as the conclusion of the MEP.

In Fall 2024, the Expansion Committee was established to proactively discuss expansion efforts for Sorority growth and develop resources for expansion efforts.

Thank you to the members of the Expansion Committee representing different aspects of our past and present Leadership Team and a recent District Officer for contributing to our deep discussions throughout this past year!

In our first efforts, we conducted a current state assessment of our Chapters, capacity of the Sorority to take on new prospective Petitioning Groups, and reviewed our current outreach efforts and progress. We then focused on communication resources and establishing strategy for ongoing outreach and communication. For this past year this includes release of the "Why TBSigma" landing page as a highlight for recruitment - for both band members and Directors or Band - and a DOB-targeted postcard encouraging them to learn more about Tau Beta Sigma.

The "Why TBSigma" landing page is a succinct resource that connects our Mission and regular operations with benefits to members and band programs. You are encouraged to use it in recruitment conversations and ask your DOB to share it with their professional network as well!

Postcards were sent earlier this year to over 170 prospective band programs. This outreach focuses on programs who are similar to our current Chapters. The cards were sent in an effort to start a conversation about Tau Beta Sigma - and hopefully lead to expansion efforts in the future.

I am very excited to see how the efforts of the Expansion Committee impacts our Expansion Program in the coming years!

Now that we've talked about the Expansion of the future it is time to pivot and celebrate our Expansion from this biennium! This year we recharted six Chapters - Theta Gamma at Alcorn State University, Iota Gamma at Fort Valley State University, Theta Omega at Claflin University, Iota Theta at Edward Waters University, Theta Nu at Clark Atlanta University, and Theta Pi at Bowie State University. This was also the first biennium in approximately a decade that we conducted Fall Petitioning Group Processes! If you are a member of one of these returning Chapters please stand or wave and be celebrated! We are excited to see each of you take on the new biennium as Active Chapters and continue to make a difference for your band program and wider community.

Our Expansion Program would not be possible without the dedication of our volunteer Petitioning Group Advisors and Member Educators. Thank you to the Advisors from this biennium who supported our new Chapters.

I'd also like to extend a special thank you to this subgroup of our Advisors who assisted with an overhaul and streamlining of our Petitioning Group Process.

Over the summer and fall of 2024 I worked with the recent Petitioning Group Advisors to ensure that our Petitioning Group Process is consistent from semester to semester so that our new Chapters have a solid foundation to begin their independent operations and Advisors are able to focus on Chapter support versus redeveloping content each week.

The recommended timeline for the process was aligned to match the 8-week process of Overture with flexibility to shorten or expand as needed. We also re-ordered the content presentation to introduce material needed for operations tasks earlier. One of the largest lifts for this group was developing template presentations and facilitator guides for Advisors to be used and updated for relevancy moving forward. In an effort to complement the Chapter Operations lessons with Overture membership education content we eliminated redundant lessons from Overture and altered Module 7 to focus on establishing Chapter identity and culture.

The updated curriculum for Chapter Operations Lessons and Overture education was first rolled out in Fall 2024. It has been noted by incoming Advisors and those who have previously served as Advisors as a benefit for the education process allowing greater focus on tailoring support for each group and members feeling prepared to complete each of their tasks within the anticipated timeframe.

The NVPME role has many hats and responsibilities. One of the biggest aspects of the role is supporting Chapter Operations and providing resources when needed. Whether it is due to a disciplinary status or other identified need, support for Chapters comes in many forms - recruitment, basic meetings and communication, engagement in the Chapter and band, advocacy with band leadership, constitution and budget reviews, and so much more.

As NVPME my role is to identify needs, coordinate resources, and then follow up to ensure that needs are effectively met and provide additional support as needed. Our Chapter support efforts aren't possible without our wide network within the Sisterhood - from Chapter members identifying the need for support, to District Officers, CVAs, and Counselors fielding questions and providing answers, to our Designees working closely with Chapters to address their concerns and encourage them to be engaged with the national organization.

Thank you to our Designees who served this biennium as resources for our Chapters and helped to move Tau Beta Sigma forward in campuses across the country!

One of my favorite events to plan for this biennium is the National Leadership Conference. This weekend each summer brings District Officers together with our National Leadership Team to focus on our strategic plan, discuss needs for member support, and provide professional and leadership development for our student leaders. This year we focused on how leading with intention and vulnerability create space for others to thrive. I'm excited to see how these lessons translate into support and action that benefits each of your Districts and Chapters this year. Thank you to the District Officers for taking time to connect, share your experiences, and be so willing to grow through these weekends.

To wrap-up my report I'd like to leave you with some numbers about the current state of Tau Beta Sigma. This biennium marked an important moment for membership with growth in both returning Active members and new Initiates for the first time since 2018-2019. This was driven from over 4000 returning members and more than 2400 new Initiates! We had 131 Chapters continue through the biennium and re-Installed six Chapters. There were also 1100 Active members who graduated and we had 90 members (in general) become Life Members. Overall, these numbers show we had a growth of 4% this biennium!

And now come the thank yous.

- TBSAA Executive Council Thank you to the EC for being a continuous source of support, answering the call when we could collaborate or had a need for special support, and continuing to cultivate an engaging environment for our Alumni.
- Board of Trustees Thank you for prioritizing stability and long-term success for Tau Beta Sigma. Through tough conversations, advocacy work, and being resources for

- myself and the rest of the National Council we are setting ourselves up for a bright future through our 80th Anniversary and the next 80 years.
- Chapter Visitation Associates As we say, the CVAs are the "fun aunts and uncles of Tau Beta Sigma". Your role provides essential support and insight to the operations and engagement of our Active members and Chapters. I know that whenever a need arises there will be CVA hands up and ready to volunteer to support our programs and members.
- District Counselors The Counselor role is at the heart of Tau Beta Sigma for me. Counselor work is a blend of support and accountability, collective growth and individual encouragement, and connecting students to the wider organization. There is no part of our operations and programs that Counselors don't have an impact on. Thank you for being the front line resources and cheerleaders for our members and Chapters. Thank you for being sounding boards for myself and the National Council. And thank you for your time, efforts, and love given in support of Tau Beta Sigma.
- National Headquarters Staff While I'm certain that you are not in the room and are out and about supporting NatCon, thank you for your tireless efforts this biennium to support the needs of the Council, our Chapters, and members. There is so much that goes on behind the scenes in the day-to-day of our work that you make possible. Thank you!
- National Council What. a. Biennium. Thank you for being ready to pivot. To take on the new. To ask questions and work together to find answers. From late night conversations to morning toothbrushing parties to tears to laughs. We've covered it all in these short two years. Thank you for leading and supporting and helping to grow Tau Beta Sigma through our current successes and to our bright future ahead.
- Our Students Thank you to each and every member of Tau Beta Sigma. From the newest initiate through our Chapter leaders and District Officers. Our work as an organization is made real with your efforts day in and out in your band program, on your campus, and in your community. Your growth, your development, and your efforts will lead Tau Beta Sigma to where we can grow next. Thank you for showing up today and for all that you'll choose to take on tomorrow!
- Leslie The one individual I am going to celebrate in these thank yous is Leslie Gartin My thank yous for you should really extend back to our first time as roommates in 2016, but that would take us all the way through the banquet tonight to cover! So we'll focus instead on the past two years. No one could have imagined the blackout BINGO card that we have filled this biennium. Right after our transitions in March 2024 you placed your focus on continuing the work of the organization, ensuring that our programs, conventions, and the experience of Active members didn't skip a beat. Thank you for leading through many transitions and advocating for the voice of the National Council and the best interests of Tau Beta Sigma. I hope that moving forward you feel proud of your work not just this biennium, but as an Alumni leader, District Counselor, National

Officer, and as National President. I hope that you take in all of the celebrations as we continue on in this National Convention. Thank you for being my Sister and my friend.

To wrap up my thank yous I want to end with a quote and a smattering of Canva icons significant to those in the know - Find a group of people who challenge and inspire you, spend a lot of time with them, and it will change your life (Amy Poehler). Thank you to all who challenged and inspired me this biennium both in Tau Beta Sigma and beyond. I'm so lucky to have so many wonderful people in my life. For our National Delegation, I hope that you will find people who challenge and inspire you - learn from them and laugh with them and grow alongside them.

This biennium taught me that leadership is less about where you thought you'd be, and more about who you choose to become when the path changes. I leave this chapter grounded in deeper friendship, greater purpose, and a renewed belief that band people are the best people in the world.

Appendix M: Report of the Nominations Committee

The 2025 Nominations Committee was charged with the following:

- 1. Read the 2023 nominations committee report.
- 2. Determine the eligibility of the candidates for national council as outlined in the Tau Beta Sigma National Constitution.
- 3. Develop interview procedures and formulate questions for all candidates for National Office.
- 4. Recommend a slate for National Office
- 5. Make decisions that reflect the best interests of the sorority

We determined the eligibility of each candidate for National Office based on the requirements outlined in articles 3.203, 3.204, and 3.205 of the 2023-2025 Tau Beta Sigma National Constitution.

<u>3.203</u> Each National Officer shall be a Life Member of the Sorority in good standing and at least twenty-five (25) years of age at the time of election. Each National Officer shall have completed an undergraduate degree program. Each National Officer shall possess outstanding business ability and shall be capable of representing the Sorority under all ordinary conditions. All shall

be willing and able to devote the necessary time to the execution of the duties imposed by the office and shall be actively participating in or serving bands during their term of office

<u>3.204</u> Each National Officer shall serve for a period of two (2) years from convention to convention. The National Vice President for Membership and Expansion shall be advanced to the office of National President provided said officer receives a simple majority vote of the convention. The National President and Vice President for Membership and Expansion shall not be eligible for reelection.

<u>3.205</u> The National President shall be designated as the Executive Officer of the Sorority and of the National Chapter and the National Council. The National President shall be a non-voting member of all committees, except for the Nominating Committee, of which they cannot be a member, and shall sign all charters, shingles, contracts, and other instruments of the business of the Sorority. Said officer shall appoint all standing and special committees, shall be a member ex-officio of the corporation's Board of Trustees, and shall further be designated as the official representative of the National Chapter, whenever such representation shall be required. In addition, the National President shall have held at least one National Office.

The candidates briefly introduced themselves in our separate session. They also spoke during our mixed caucuses on Thursday, where they reintroduced their platforms and took questions from the delegates. Each of the candidates for National Office had submitted application packets before convention.

Our committee time was slightly thrown off due to the Past National President Panel, but eventually we met for a total of 3.5 hours with about 30 minutes going towards putting our list of questions together, 2.5 hours were spent on interviews, and then 45 minutes were spent discussing the formal slate.

We asked the following questions:

GENERAL QUESTIONS:

- 1. "What is your greatest achievement outside of TBS, and how can you apply the skills you learned to your office if elected?"
- 2. "Tell us about a time you rolled out a program and how you encouraged others to participate."
- 3. "What is a recent shortcoming you have experienced in TBS, and how did you navigate it?"

- 4. An important part of our mission statement is "equality and diversity" how do you plan to support the efforts of the current council in expanding and recognizing diversity in our organization?"
- 5. "How does the current vision statement align with your goals for office?"

President ONLY

- 1. "What is your vision for the biennium and the 2027 convention?"
- 2. "What strategies do you intend to implement to enhance nationwide engagement across all areas of Tau Beta Sigma, including timely paperwork submission, participation in national and district events, and interaction with the National Council?"

Vice President for Membership and Expansion ONLY

- 1. "Do you have plans to modify Overture in any way, and if so, how do you believe those will benefit the organization?"
- 2. "What specific goals do you have for increasing chartering and petitioning groups and how will you carry them out?"
- 3. Do you plan to continue with Rondo? If so, what are your goals for that?
- 4. "What are your plans for supporting chapters of various sizes in regards to recruiting members?"

Vice President for Special Projects ONLY

- 1. "What specific goals do you have for Fo5 and how will you carry them out?"
- 2. "How do you intend to encourage participation from chapters who currently have low participation rates?"
- 3. "How do you plan to encourage practice and musicianship in chapters?"
- 4. "What would be your approach to identifying and networking with potential women in music speakers at the district and national level?"
- 5. "What are qualities that set you apart from other candidates?"

Vice President Communication & Recognition ONLY

- 1. "How do you plan to use our social media to better reach and engage our members at all Levels?"
- 2. "How will you enhance participation in regards to national awards and scholarships?"
- 3. "How do you plan to effectively utilize the Communications Committee?"

ALL

- 1. "Is there anything else in your packet, platform, or about you that you have not been able to speak on yet and you would like us to know?"
- 2. (Excluding president) "Are there any other positions you are willing to be slated for besides the one you are applying for now?"

We used the questions from the 2023 report as a foundation for the questions we asked this year, with some staying exactly the same, some being slightly modified, and some being removed with new ones replacing them entirely. We were really happy with the answers we got from all the questions, but especially general question 5 because it caught our candidates off guard a bit which led to very candid answers.

Appendix N: Report of the Programs Committee Committee The 2025 Programs Committee was charged with the following:

Charged by 2023 Programs Committee

- 1. Review the report of the 2023 Programs Committee.
- 2. Review the report from the National VPSP that addresses the state of the National programs.
- 3. Review the National Programs Guide
- 4. Review the effectiveness of Focus on 5 as a motivator to complete the National programs.

Charged by National Council

- 1. Review New Green Stripe challenge
- 2. Ways to refresh the black stripe for the greater practice awards
- 3. Review the efficacy of moving the Fo5 Submissions to the discord

The Following documents were reviewed

- 2023 committee report
- Tau Beta Sigma Programs Guide
- TBSigma.org Website

The first thing the committee reviewed was the report of the 2023 programs committee, along with the charges set by the National Council. General takeaways from the 2025 Programs Committee were:

- Confusion with multiple parts of the black stripe including what constitutes the needed hours and what qualifies as a successful submission
- In general must programs had caused issues with burnout and intensive resource requirements needed to fulfill them
- Effectiveness of the white and green stripes

Out of these we saw the merging of the white stripe and green stripe and a further focus to work on the black stripe.

Going in order of Programs and where they correspond with the focus on five program

Starting with the **Red Stripe**, we saw that it was effective at reaching its goals and needed no change this biennium.

The **White Stripe** was deemed to be reaching its overall goal. Additionally, the synthesis of the two programs into the one creates more ways to complete the program. The main issue that the majority found consensus on was that the attendance requirement was the main hurdle to completion.

The **Blue Stripe** was seen as accomplishing its goals phenomenally, the only addition we would like to see would be a database of past Women in Music Speakers that would be open to presenting again, as a way to give options to those chapters that are struggling to find someone in their area.

The new **Green Stripe** we found to be a great start and those who were able to get the event off the ground saw results that matched the goal of the stripe, however it is currently missing the resources such as examples and further clarification that the more established programs have had the luxury of having. The chapters that ran it closer to workshops saw better success rates, however having the options open to other activities creates more accessibility to chapters

The **Black Stripe** was deemed to be falling short of accomplishing its stated goals in the program's guide.

- We found that the current set of regulations had issues with the following:
 - Clarity on what the hours needed are and how the math is done
 - Different on website and the guide

- Smaller chapters had issues with the amount needed
- If the performance could be combined with one of the other programs such as Coda or not
- Difficulty in finding and using the practice log that was provided
- Disparity in majors, especially those that are time consuming
- Music majors used to clock in all the hours, causing burnout
- Disparity in rehearsal and performance spaces and/or complete lack there of
- The time frame of three consecutive months, with a concert at the end, does not allow for actual ebbs and flows of time that can be used for practice in the life of students
- Majority of committee would be open to a complete rework with the following requirements in mind:
 - Focus on the purpose of the program (creating better musicians), rather than just the act of practicing
 - Keep in mind that some chapters are majority music majors and vice versa
 - Accessibility of time and attendance
 - The limiting factors of different instruments such as large instruments, percussion, visual performers and auxiliaries
- Some examples that the committee came up with were:
 - Concert and recital attendances
 - Mock Juries
 - Chapter sight read to performance piece
 - Chapters would record the first playthrough as well as different times of the year to show improvement over time
 - Rework of practice hours addressing the challenges that were faced
 - Hosting a masterclass workshop

For the submission platform change from Facebook to Discord

- The feedback that was received was tremendously positive towards the change and discord itself
- Better advertisement and where to find it would be helpful
- Helps condense all the information into on local location
- A push to have Districts, and chapters to use the discord along with email to have ease of access all TBS communication on just one app/social media
- Instructions to do this would be helpful
- Security/privacy with stripe submission was a concern
- Can be resolved through roles possibly

The Programs Guidebook had a decent amount of conversation.

- Organize the programs by their corresponding stripes
- Provide real life examples of projects that were successful as well as some submissions that did not make it and explanations on why they were not accepted
- Add the green stripe as an official program in the guide
- A version of the document that is more accessible with things such as a dyslexia friendly font, text colour, etc

The Committee charges the 2027 Programs Committee with the following:

- 1. Review the report of the 2025 Programs Committee.
- 2. Review the Charges set forth by the NVPSP
- 3. Review the status of the Black Stripe
- 4. Review if clarification of the green stripe has been added
- 5. Review the National Programs Guide

The Committee charges the National Vice President of Special Projects with the following:

- 1. Create a more reasonable attendance policy or remove the attendance requirements for the White Stripe and judge based on its end results instead
- 2. Look into the feasibility of a WIMS database for chapters to have contacts to use for future blue stripes
- 3. Finish making the Green Stripe into a full program, and adding it and the resources needed to run it into the programs guide.
- 4. Rework the Black Stripe with goals stated as above
- 5. Better advertisement of the Discord
- 6. Recommendation of changing the layout of the Programs Guidebook to reflect the Focus on Five Campaign
- 7. Add real examples of successful submissions as well as some that are not, giving explanations of why
- 8. Create a disability friendly version of the guidebook for those with dyslexia or other visual disabilities

The Committee charges Districts with the following:

1. Further use of discord, to limit the amount of ancillary apps to limit confusion and simplify where to look for communication along with email

Appendix O: Report of the History & Traditions/Ritual & Regalia Committee

The 2025 History & Traditions/Ritual & Regalia Committee was charged with the following:

- 1. Desire to have a pin to be gifted with *Baton* recipients to be worn. Discussion on designing options, or having the council present designs, etc. Final approval by the 2025-2027 National Council.
- 2. Discuss historical items that could be researched and resourced further. (ex. Sorority songs, Focus on Five, Women in Music)
- 3. Discuss best ways to distribute historical projects. Printed doc, online publication, YouTube, etc.

This committee met twice over the course of the 2025 National Convention. We first began with discussion of designing a pin to be presented to recipients of *The Baton*, and reviewed the meaning and visuals of the award. We then further discussed elements we would like to see in the pin such as shape, color, and basic design. After our initial discussion, committee members were able to submit sketches and possible jewelry designs for future discussion. We discussed and voted on our top five designs to be submitted to the 2025-2027 National Council for review and final approval.

Following our initial discussion of designing a pin, committee members had a round table asking and conversing on any/all questions regarding our history and relationships as an organization. This shifted to a larger discussion on alumni relations within chapters as well as chapter family trees and nicknames. For these topics, we encourage the national delegation to keep holding these conversations with each other, especially within your chapters, to seek ways to connect and collaborate more with your present and past members, and keep an index of some sort as a record for the history that is unique to your chapter.

Lastly, we discussed the best ways to distribute and store historical projects. Committee members expressed documentation should stay relevant with current social distribution trends such as Youtube, short content on tiktok and even saving stories on instagram highlights. The committee would like to see testimonials from alumni and students alike, and emphasized the need for chapter specific hymns and chants to be documented and stored. We then further discussed the current methods of distribution (national website) and the current tabs dedicated to the history of Tau Beta Sigma. In addition, we discussed the possibility of having history workshops at district conventions to review the work and archives readily available such as how to recover installation documents. The committee encourages district councils to consider this in their district event planning and/or execute this as district programming.

The Committee charges the 2027 History & Traditions/Ritual & Regalia Committee with the following:

- 1. Review the report of the 2025 History & Traditions/Ritual & Regalia Committee.
- 2. Discuss historical items that could be researched and resourced further. (ex. Sorority songs, Focus on Five, Women in Music)

The Committee charges the 2025-2027 History & Archives Committee with the following:

- 1. Research the current demographics of our organization and evaluate its connection to our history through collaboration with the DEIA committee.
- 2. Research the marginalized groups within Tau Beta Sigma, including but not limited to our HBCU and HSI chapters, LGBTQ+ and AAPI communities, and update the existing history tabs on the national website with sections dedicated to each.
- 3. Consider presenting a collection/series on YouTube featuring and highlighting our chapters, alumni, chapter hymns, and more that make our chapters unique, as well as shorter features such as Instagram reels or TikTok.

The Committee charges the 2025-2027 National Council with the following:

- 1. To review and discuss the presented pin sketches, and curate a final design to be gifted to recipients of *The Baton*.
- 2. Continue to elevate the voices of our diverse body of membership.

The following five designs were created, voted on, and discussed by the committee:

Appendix P: Report of the Jurisdiction Committee

The 2025 Jurisdiction Committee was charged with the following:

- 1. Review the report of the 2023 Jurisdiction and Finance Committee
- 2. Review the Constitution and make sure it reflects the current business practices of the sorority
- 3. Charge the 2025-2027 National Council with updating Constitution Article Numbers
- 4. Review and discuss the constitutional proposals received and submitted by the National Council.

The 2025 Jurisdiction Committee was passed along proposals for amendments to the Constitution from the National Council. These proposals were split into the following categories to be discussed and voted on by the committee. These categories are as follows: Grammar and Consistency, Clarity and Streamlining, National Current Practice Updates, Other Current Practice Updates, and the Budget Review and Approval Process.

The proposed charges for the first section are of the **Grammar and Consistency** category as illustrated in the report below:

a. Rewording of whole document regarding Nominations Committee

Current: The committee is referred to as the Nominating Committee in the Constitution.

Proposed: The committee shall now be referred to as the Nominations Committee in the Constitution

Rationale: The committee is referred to as the Nominations Committee in our current practice, and this change reflects the current practice.

b. Rewording of whole document regarding committee names

Current: Committees in name are referred to as "Committee on X" in the Constitution.

Proposed: Committees in name are referred to as "X Committee" in the Constitution.

Rationale: Committees are referred to as "X Committee" in our current practice, and this change reflects that.

c. Rewording of whole document regarding non-voting members

Current: Members unable to vote are referred to as "nonvoting" members in the Constitution.

Proposed: Members unable to vote shall be referred to as "non-voting" members in the Constitution.

Rationale: "Non-voting" is proper grammar compared to "nonvoting."

d. Rewording of whole document regarding non-members

Current: People who are not members of the sorority are referred to as "nonmembers" in the Constitution.

Proposed: People who are not members of the sorority shall be referred to as "non-members" in the Constitution.

Rationale: "Non-members" is proper grammar as opposed to "nonmembers."

e. Rewording of whole document regarding the word "non-elected"

Current: The National President and immediate past National President are referred to as "nonelected members" of the Board of Trustees in Article 2.103

Proposed: The National President and immediate past National President shall be referred to as "non-elected members" of the Board of Trustees in Article 2.103

Rationale: "Non-elected" is proper grammar compared to "nonelected."

f. Rewording of whole document regarding Life Members

Current: The plural of "Life Member" is "Life members" in Article 2.104 and Article 2.106.

Proposed: The plural of "Life Member" shall be "Life Members" in Article 2.104 and Article 2.106.

Rationale: This change is to ensure consistency with our general communications.

g. Rewording of whole document regarding National Officer titles including "and"

Current: National Officer titles including "and" are notated with the word "and" in the Constitution.

Proposed: National Officer titles including "and" shall be notated with the ampersand (&) in the Constitution.

Rationale: Our current practice is to refer to those Officers with ampersands and this change reflects that.

h. Rewording of whole document regarding "non-refundable"

Current: Fees and funds unable to be refunded are referred to as "nonrefundable" in Article 3.501.

Proposed: Fees and funds unable to be refunded shall be referred to as "non-refundable" in Article 3.501.

Rationale: "Non-refundable" is proper grammar as opposed to "nonrefundable."

i. Rewording of whole document regarding "Chair" vs "Chairperson"

Current: Article 3.801 refers to the "Board of Trustees Chair"

Proposed: Article 3.801 shall instead refer to them as the "Board of Trustees Chairperson"

Rationale: This change ensures consistency throughout the entire document, as they are referred to as the Chairperson in the rest of the Constitution.

j. Article 2.103

Current: "from the end of one National Convention through the end of the next National Convention"

Proposed: "from convention to convention"

Rationale: This proposal is to keep consistency with language between the Board of Trustees and National Council elections and terms. It also reflects the current practice of how the Board of Trustees onboarding work and operations for National President to Immediate Past President at SCM.

k. Article 3.204

Current: "The National President and Vice President for Membership and Expansion shall not be eligible for reelection."

Proposal: "The National President and National Vice President for Membership and Expansion shall not be eligible for reelection."

Rationale: This proposal is to keep consistency within the document.

l. Article 6.106

Current: "Chapters that do not have enough members to fill the roles of President, Vice-President, Treasurer, and Secretary will be automatically placed on Observation status." **Proposal:** "Chapters that do not have enough members to fill the roles of President, Vice President for Membership, Treasurer, and Secretary will be automatically placed on Observation status."

Rationale: This proposal is to ensure consistency and clarify when referring to the position of Vice President of Membership.

m. Article 6.107

Current: "OBSERVATION. Upon due cause, the National Council shall place the chapter on Observation."

Proposal: "OBSERVATION. Upon due cause, the National Council shall place said chapter on Observation."

Rationale: This proposal is to ensure consistent language within the document, specifically between the proposed Article and Articles 6.105, 6.108, and 6.109.

n. Section 6.2 and all subsequent articles

Current: The articles refer to the Vice President and Vice President of Membership.

Proposal: The articles shall instead refer to the Vice President for Membership.

o. Article 6.205

Current: "chapter officers shall serve without compensation."

Proposed: "Chapter officers shall serve without compensation."

Rationale: This proposal is a simple correction of a grammatical mistake.

p. Article 6.608

Current: "If a member's collegiate education continues past four years, and they is unable to meet Active, Associate, or Conditional requirements, they may elect to have Alumni status, with Chapter and Sponsor approval."

Proposal: "If a member's collegiate education continues past four years, and they are unable to meet Active, Associate, or Conditional requirements, they may elect to have Alumni status, with Chapter and Sponsor approval."

Rationale: This proposal is a simple correction to a grammatical error.

q. Article 6.621

Current: "Prior to a vote on expulsion, the member has a right to a hearing before the active Her/His chapter membership and chapter Sponsor or Director of Bands."

Proposal: "Prior to a vote on expulsion, the member has a right to a hearing before the active chapter membership and chapter Sponsor or Director of Bands."

Rationale: The pronouns are unnecessary and the removal of them makes the article flow more and read easier.

r. Article 6.701

Current: "A Delegate, Alternate Delegate, or Proxy shall represent each chapter at each District and National Chapter Convention."

Proposal: "A Delegate, Alternate Delegate, or Proxy shall represent each chapter at each District and National Convention."

Rationale: This proposal is for both clarity and consistency throughout the document when referring to National Convention.

s. Article 6.701

Current: "In the absence of a Delegate and an Alternate Delegate to a National Convention or District Convention, each chapter may designate the Alternate Delegate of another chapter in attendance at the Convention to serve as Proxy."

Proposal: "In the absence of a Delegate to a National Convention or District Convention, each chapter may designate an Alternate Delegate of another chapter in attendance at the Convention to serve as Proxy."

Rationale: This proposal is both to clarify how the Alternate Delegate role works and to correct grammar.

t. Rewording of whole document regarding Counselor

Current: The document currently refers to a singular Counselor.

Proposal: The document shall refer to plural Counselor(s).

Rationale: This is because it is common practice to have multiple counselors.

The proposed charges for the second section are of the **Clarity and Streamline category** as illustrated in the report below:

a. Article 2.110

Current: "The person shall meet the requirements as stated in Section 2.105 and 2.107, subject to the approval of the remaining voting members of the Board of Trustees."

Proposal: "The person shall meet the requirements as stated in Section 2.106 and 2.107, subject to the approval of the remaining voting members of the Board of Trustees."

Rationale: This article is referencing requirements to be on the Board of Trustees that are stated in 2.106, while the current article being referenced is about the structure of the Board of Trustees. This is assumed to be a typo in the current edition.

b. Article 2.111

Current: "The Board shall elect a Chairperson and Vice Chairperson from the Board members elected by the Life Members of the Sorority. The retiring Chairperson and Vice Chairperson shall be eligible for reelection."

Proposal: "The Board shall elect a Chairperson and Vice Chairperson. The National President and Immediate Past National President are not eligible for these roles. The retiring Chairperson and Vice Chairperson shall be eligible for reelection."

Rationale: This proposal clarifies what Board of Trustee members are eligible to be elected for the role of the Board of Trustees Chairperson and Vice Chairperson roles. The committee elected to remove the clarification of who votes for the Board of Trustee members since it is already defined in Article 2.105.

c. Article 2.117

Current: "unanimous vote of the Board of Trustees, not including the member in question and the non-voting members, and a three-fourths (3/4) vote of the National Council."

Proposal: "unanimous vote of the Board of Trustees, not including the member in question, and a three-fourths (¾) vote of the National Council."

Rationale: This streamlines the language of the article as there is only one non-voting member - the National President.

d. Articles 3.504 and 3.505

Current:

"3.504 In recognition of outstanding ability, accomplishment, or devotion to the best interests of the Sorority, any member of the Sorority may be voted a National Honorary Life Member by a seventy-five (75) percent favorable vote of the National Chapter. This shall be the highest honor which can be conferred upon a member of the Sorority.

3.505 The retiring and past National Presidents of the Sorority may be voted a National Honorary Life Member in recognition of the past service to the Sorority by a seventy-five (75) percent favorable vote of the Delegates at a regularly called National Convention."

Proposal:

"3.504 In recognition of outstanding ability, accomplishment, or devotion to the best interests of the Sorority, any member of the Sorority may be voted a National Honorary Life Member by a seventy-five (75) percent favorable vote of the National Chapter. This shall be the highest honor which can be conferred upon a member of the Sorority. The retiring and past National Presidents of the Sorority may be voted a National Honorary Life Member at a regularly called National Convention."

Rationale: Combining these two clauses is to both avoid redundancy and to streamline language and formatting.

e. Article 3.603

Current: "Once all rounds of seating via proxy and alphabetical seating have concluded, proxies and alternate delegates have all rights and privileges as delegates and may not be unseated by the tardy arrival of a chapter delegate."

Proposal: "Once all rounds of seating have concluded, Proxies and Alternate Delegates have all rights and privileges as Delegates and may not be unseated by the tardy arrival of a chapter delegate."

Rationale: This proposal is both to maintain consistency within the entire document and to streamline, clarify, and remove redundant information.

f. Article 3.605

Current: "In the absence of the District President, the District Vice President shall represent the District."

Proposal: "In the absence of the District President, the District Vice President for Membership shall represent the District."

Rationale: It is assumed throughout the document that whenever "Vice President" is used, it refers to the "Vice President for Membership," and this proposal is to clarify that language.

g. Article 3.702

Current: "The Special Committees of the National Chapter shall be any other Committees, such as the Committee on Appeals, as may be considered necessary by the National Chapter and National Council."

Current: "The Special Committees of the National Chapter shall be any other Committees, such as the Sisterhood and Spirit Committee, as may be considered necessary by the National Chapter and National Council."

Rationale: The Committee on Appeals is an outdated committee that is not in use anymore. This proposal suggests to replace it with a more modern and more utilized committee, in this case the Sisterhood and Spirit Committee.

h. Article 3.1004

Current: "The various items of jewelry shall include a coat of arms (Recognition Pin), badge, membership candidate pin, recognition bar, monogram pendant, and alumni guard."

Proposal: "The various items of jewelry shall include, but are not limited to: a coat of arms (Recognition Pin), badge, membership candidate pin, recognition bar, monogram pendant, and alumni guard."

Rationale: This clarifies that the given list does not include all options (e.g. Life Member pins, etc.).

The proposed charges for the third section are of the **National Current Practice Updates category** as illustrated in the report below:

a. Updating the Chapter Visitation Associate

Current: "5.302 The Chapter Visitation Associate(s) shall have no jurisdiction over the day to day functioning of the District or District Council Chapter Visitation Associate(s) will coordinate with the District Counselor(s) of the District of the chapter they are visiting. Chapter Visitation Associates(s) shall assist only with routine chapter visits and investigations. Other visits that are deemed necessary for other reasons will be conducted by the District Counselor(s).

Proposal: "3.203 Chapter Visitation Associate(s) will coordinate with the District Counselor(s) of the District of the chapter they are visiting. Chapter Visitation Associate(s) shall assist only with routine chapter visits and investigations. Other visits that are deemed necessary for other reasons will be conducted by the District Counselor(s).

Rationale: As the CVA position is not District-bound, language pertaining to any district jurisdiction was removed and the subsequent sections moved to the National Chapter section from the District section

Current: "5.304 The District Council and District Counselor will be notified within ten (10) days prior to the public announcement of the addition or replacement of a Chapter Visitation Associate

Proposal: Removal of the article.

Rationale: Updating to current practice of CVA not being district bound

(Changing Section from 5.3 to 3.3 and defining as Appointed Positions)

b. Defining the Chapter Designee role

Proposal:

- "3.304 The Chapter Designee shall be appointed by the National President and be approved by the National Council. Each Chapter Designee will serve at the discretion of the National President. Each Chapter Designee shall be a Life Member and have completed an undergraduate degree. Chapter Designee(s) shall serve without compensation. Expenses incurred on behalf of the Sorority shall be paid upon presentation of written statement to the National Executive Director, subject to approval by the National President.
- 3.305 Chapter Designees are assigned to Chapters in need of operational support, and as needed, to support and work on a regular basis with the Chapter and its Officers.
- 3.306 A Chapter Designee may be removed from the position by unanimous vote of the National Council."

Rationale: The role of Chapter designee is used at the national level but was not defined

c. Defining Good Standing in regards to Chapters

Proposal: "Chapters are considered to be in good standing if they hold an Active or Observation status with the National Headquarters."

Rationale: It is never defined in the document what good standing means, and this clause would define that.

d. Defining Good Standing in regards to Members

Proposal: "Members are considered to be in good standing if they hold an Active, Conditional, Associate, Alumni, Life, or Honorary status with the National Headquarters.

Rationale: It is never defined in the document what good standing means, and this clause would define that.

e. Redefining the fiscal year

Current: The fiscal year for the National Chapter shall be from June 1 to May 31. The National Executive Director shall institute a continuous audit to have the financial records of the National Chapter audited by a Certified Public Accountant. Copies of the audit shall be submitted to the Chairperson of the Board of Trustees and to each member of the National Council.

Proposal: The fiscal year for the National Chapter shall be from September 1 to August 31. The National Executive Director shall institute a continuous audit to have the financial

records of the National Chapter audited by a Certified Public Accountant. Copies of the audit shall be submitted to the Chairperson of the Board of Trustees and to each member of the National Council.

Rationale: Upon recommendation from the national accountant the fiscal year is being aligned to the membership year to streamline accounting practices.

f. Article 3.206

Current: "The National Vice President for Membership and Expansion shall, in the absence of the National President, preside at meetings of the National Council, and shall be designated as the Expansion Officer of the Sorority. The National Vice President for Membership and Expansion shall advance the purposes of the Sorority as stated in the Preamble of this Constitution by working with District Officers in the area of expansion on behalf of the Sorority. The National Vice President for Membership and Expansion shall have held at least one National Office."

Proposal: "The National Vice President for Membership and Expansion shall, in the absence of the National President, preside at meetings of the National Council, and shall be designated as the Expansion Officer of the Sorority. The National Vice President for Membership and Expansion shall oversee all aspects of membership including the education of new and continuing members and all expansion efforts on behalf of the Sorority. The National Vice President for Membership and Expansion shall have held at least one National Office."

Rationale: This proposal updates the document on how our NVPME works and their current practice.

g. *Article 3.208*

Current: "The National Vice President for Communication and Recognition shall sign all charters, shingles, contracts, and other instruments of business."

Proposal: "The National Vice President for Communication and Recognition shall sign all charters, shingles, and other instruments of business."

Rationale: It is not current practice for the National Vice President for Communication and Recognition to sign contracts; this proposal reflects the current practice.

h. Article 3.214

- **Current:** "A National Officer may be removed from office by a unanimous vote of four (4) National Officers and a seventy-five (75) percent favorable vote of the Board of Trustees."
- **Proposal:** "A National Officer may be removed from office by a unanimous vote of four (4) National Officers, not including the member in question, and a seventy-five (75) percent favorable vote of the Board of Trustees."
- **Rationale:** It does not make sense for the process of removal of a National Officer to be a unanimous vote including the member in question as the member in question will be biased towards themselves. This proposal also aligns more with the Board of Trustees member removal process.
 - *i. Article 3.501*
- **Current:** "New chapters shall be admitted to the National Chapter of the Sorority upon submission of a petition by the petitioning group prepared in accordance with the instructions and provisions furnished by the National Chapter or National Council."
- **Proposed:** "New chapters shall be admitted to the National Chapter of the Sorority upon submission of a petition by the interest group prepared in accordance with the instructions and provisions furnished by the National Chapter or National Council."
- **Rationale:** The group is not considered a Petitioning Group until their application and begin the process. This proposal reflects the current practice of the Sorority.
 - *j. Article* 3.503
- Current: "New chapters will be installed, after the approval of their Petitioning Document, a District Counselor, or by a member appointed by the National Vice President for Membership and Expansion. A PreInstallation visit will take place within forty-five (45) days following the approval of the petitioning document. The installation will take place after the Pre-Installation visit occurs."
- **Proposal:** "New chapters will be installed, after the approval of their Petitioning Document, a District Counselor, or by a member appointed by the National Vice President for Membership and Expansion."

Rationale: PreInstallation visits no longer occur, and this proposal reflects our current practice.

k. Article 3.601

Current: "Each Active chapter of the Sorority shall be represented at National Conventions by an Official Delegate, Alternate Delegate, or Proxy. Each chapter shall file the official Delegate form with National Headquarters. A Life Member may represent their own chapter at National Convention if there is no Delegate from that chapter present. Chapters on Administrative Hold shall be represented by a Proxy, but may not send a Delegate unless authorized by the National Council. Chapters on Probation may have a Delegate dependent upon the terms of the Probation status. Inactive and Suspended chapters shall have no representation."

Proposal: "Chapters in good standing with the Sorority shall be represented at National Conventions by an Official Delegate, Alternate Delegate, or Proxy. Each chapter shall file the official Delegate form with National Headquarters. A Life Member may represent their own chapter at National Convention if there is no Delegate from that chapter present. Chapters on Administrative Hold shall be represented by a Proxy, but may not send a Delegate unless authorized by the National Council. Chapters on Probation may have a Delegate dependent upon the terms of the Probation status. Inactive and Suspended chapters shall have no representation."

Rationale: This change is to include chapters with the Observation status.

l. Article 3.1004

Current: "Official jewelry of the Sorority shall be manufactured and sold under the terms of a contract made with a reputable manufacturer and signed by the National President and National Vice President for Communication and Recognition, exclusively."

Proposal: "Official jewelry of the Sorority shall be manufactured and sold under the terms of a contract made with a reputable manufacturer and signed by the National President, exclusively."

Rationale: This proposal removes the National Vice President for Communication and Recognition since it is not regular practice for the NVPCR to sign contracts. Instead, contracts are signed by the National President and NXD.

The proposed charges for the fourth section are of the **Other Current Practice category** as illustrated in the report below:

a. Establishing CIT Program Language

Proposal: "5.301 Upon the discretion of the National President, a Counselor-in-Training shall be appointed and approved by the National Council, in preparation for retiring District Counselors.

Rationale: This proposal is to establish the language and clause for Counselor(s)-in-Training.

b. Article 5.410

Current: "If a District Officer's chapter is placed on Suspension, Probation, or Administrative Hold, the officer's status will be reviewed by the District Counselor. Any action will be recommended by the District Counselor and reviewed by the National Council."

Proposal: "If a District Officer's chapter is placed on Suspension, Probation, or Administrative Hold, the officer's status will be reviewed by the National Council. The District Council and Counselor must be notified within ten (10) days of any action."

Rationale: This proposal is to clarify the process, as the National Council determines the status for the District Officer.

c. Article 5.602

Current: "All chapters bidding to host a District Convention must adhere to the National Guidelines for Bidding and Hosting a District Convention. Each bid submitted must contain at least two (2) available dates. The National Officers in attendance at the convention must approve any exceptions."

Proposal: Removal of the article.

Rationale: It is no longer in our current practice to bid for hosting a District Convention.

d. Article 5.701

Current: "Each Active chapter of the District shall be represented at regularly called District Conventions by an Official Delegate."

Proposal: "Each Chapter of the District in good standing shall be represented at regularly called District Conventions by an Official Delegate."

Rationale: This proposal mimics the language in 5.703 to keep consistency.

e. Article 6.104

Current: "Each chapter shall have its own constitution that shall be approved by the Chapter Sponsor."

Proposal: "Each chapter shall have its own constitution that shall be approved by the Chapter Sponsor and District Counselor(s)."

f. Article 6.106

Current: "All reports to the National Headquarters shall be submitted electronically though the current Online Membership Reporting System (OMRS)."

Proposal: "All reports to the National Headquarters shall be submitted electronically though the current online membership system."

Rationale: We do not use OMRS anymore in our current practice.

g. Article 6.107

Current: "The District Counselors and District Officers shall offer additional assistance to the chapter to understand and meet the expectations and obligations of the National Council."

Proposal: "A Designee will be assigned by the National Council to offer additional assistance to the chapter to understand and meet the expectations and obligations of the National Council."

Rationale: According to our current practice, we apply support through a Designee first which could be a Counselor, but even so they function as a Designee.

h. Article 6.109

Current: "The chapter may only meet under the supervision of the Director of Bands or their designee to address the conditions of the Suspension."

Proposal: "The chapter may only meet under the supervision of the Director of Bands or an individual from the university they designate to address the conditions of the Suspension."

Rationale: Designee refers to the role of "Chapter Designee," so this proposal clarifies the difference in language.

i. Article 6.106 and Article 6.206

Current:

"6.106... The Chapter Summary Report shall be submitted electronically to the National Headquarters Staff no later than June 1st."

"6.206 The President shall preside at all meetings of the chapter and shall be a nonvoting member of all chapter committees which shall be appointed by the President. The President shall sign all checks for monies disbursed and shall sign all contracts and other instruments of business incurred by the chapter. The President shall be responsible for filing a Fall Activity Report and chapter Summary Report to the National Headquarters. In addition, the President shall be designated as the official representative of the chapter whenever such representation shall be required."

Proposal:

"6.106... The Spring Activity Report shall be submitted electronically to the National Headquarters Staff no later than June 1st."

"6.206 The President shall preside at all meetings of the chapter and shall be a nonvoting member of all chapter committees which shall be appointed by the President. The President shall sign all checks for monies disbursed and shall sign all contracts and other instruments of business incurred by the chapter. The President shall be responsible for filing a Fall Activity Report and Spring Activity Report to the National Headquarters. In addition, the President shall be designated as the official representative of the chapter whenever such representation shall be required."

Rationale: This proposal is just an update of title based on our current practice.

j. Article 6.304

Current: "Income of the chapter shall be derived from annual dues assessed each Active member and fundraising projects conducted by the chapter. Dues shall be determined by the chapter but shall include all annual national membership fees as determined by the National Chapter and payable to the Tau Beta Sigma Sorority on or before September 30

of each year. Chapter Dues shall not exceed 75% of National Dues annually per member, unless pre-approved by the National Council."

Proposal: "Income of the chapter shall be derived from annual dues assessed each Active member and fundraising projects conducted by the chapter. Dues shall be determined by the chapter but shall include all annual national membership fees as determined by the National Chapter and payable to the Tau Beta Sigma Sorority on or before September 30 for semester-system schools and October 15 for quarter-system schools of each year. Chapter Dues shall not exceed 75% of National Dues annually per member, unless pre-approved by the National Council."

Rationale: This proposal reflects our current practice and this is just to add the clause into the document.

k. Article 6.305

Current: "Each chapter shall pay an annual national chapter fee as determined by the National Chapter which is payable to the Tau Beta Sigma on or before September 30 of each year."

Proposal: "Each chapter shall pay an annual national chapter fee as determined by the National Chapter which is payable to the Tau Beta Sigma on or before September 30 for semester-system schools and October 15 for quarter-system schools of each year."

Rationale: This proposal reflects our current practice and this is just to add the clause into the document.

l. Establish MEP Definition and Creation

Proposal: "Chapters must submit a Membership Education Plan for review and approval by the District Counselor(s) prior to conducting any recruitment or membership education activities."

Rationale: This proposal is just to establish the language and article for what we already do with Membership Education Plans and activities.

m. Article 6.615

Current: "The initiation fee for each honorary member initiated by a chapter shall be submitted to the National Headquarters with an 'Initiate Registration Form."

Proposal: "The initiation fee for each honorary member initiated by a chapter shall be submitted to the National Headquarters with an 'Honorary Initiation Form."

Rationale: We no longer call the forms Initiate Registration Forms in our current practice, instead they are called Honorary Initiation Forms.

n. Article 6.618

Current: "The chapter Sponsor and District Counselor shall be notified within ten (10) days of any disciplinary action."

Proposal: "The chapter Sponsor, District Counselor(s), and National Headquarters shall be notified within ten (10) days of any disciplinary action."

Rationale: This proposal reflects both our current practice and our previous blanket statement regarding District Counselor(s).

o. Article 6.622

Current: "Active membership will be granted to the candidate upon enrollment in the band program at the new school, presentation of current membership card, written recommendation from the candidate's previous chapter, simple majority approval of the total eligible voting membership of the new chapter, payment of chapter dues, and meeting the existing grade point requirement of the new chapter."

Proposal: "Active membership will be granted to the candidate upon enrollment in the band program at the new school, written recommendation from the candidate's previous chapter, simple majority approval of the total eligible voting membership of the new chapter, payment of chapter dues, and meeting the existing grade point requirement of the new chapter."

Rationale: Our current practice does not include the presentation of current membership cards.

The proposed charges for the fifth section are of the **Budget Review and Approval Process** as illustrated in the report below:

a. Removal of Ways and Means from Standing Committees List

Current: "3.701 The Standing Committees of the National Chapter shall be: Committee on 11 | Page Nominations, Committee on Jurisdiction, Committee on Membership and

Expansion, Committee on Programs, Committee on Ways and Means, Committee on Credentials, Committee on History and Traditions, Committee on Ritual and Regalia."

Proposal: "3.701 The Standing Committees of the National Chapter shall be: Committee on 11 | Page Nominations, Committee on Jurisdiction, Committee on Membership and Expansion, Committee on Programs, Committee on Ways and Means, Committee on Credentials, Committee on History and Traditions, Committee on Ritual and Regalia."

Rationale: The Ways and Means Committee has not been used by the national chapter in several years for the purposes of the budget review process. In order to update to most current practices, the Ways and Means Committee is being removed from the list of standing committees

b. Removal of Ways and Means Roles and Responsibilities

Current: "3.708 The Committee on Ways and Means shall examine the biennial budget proposed and drawn up through the efforts of the National President, National Vice President for Membership and Expansion, National Executive Director, and the National Headquarters auditor/accountant. It will be the responsibility of the Committee to review the budget proposals and to submit their recommendations to the National Chapter for approval. The Committee will review current funding/fundraising programs and any new proposals for programs designed to increase revenues."

Proposal: Removal of the clause.

Rationale: With the removal of the ways and means committee, the subsequent article covering the responsibilities of the committee is being removed as well.

c. Assumption of Budget Review and Approval to BOT

Current: "3.301 All monies of the National Chapter shall be received and expended by the National Executive Director. The National Executive Director shall supervise the implementation of the budget approved at biennial National Conventions. Sorority funds shall at no time be used to purchase alcohol."

Proposed: "3.301 All monies of the National Chapter shall be received and expended by the National Executive Director. The National Executive Director shall supervise the implementation of the budget approved by the Board of Trustees. Sorority funds shall at no time be used to purchase alcohol."

Rationale: In current practice the Board of Trustees has assumed the responsibility for review and approval of the national budget. In order to reflect this practice, the responsibility has been moved to the Board of Trustees.

d. Assumption of Fundraising efforts to BOT

Current: "2.101 The Corporation shall have jurisdiction over all component parts of the Sorority and shall represent them and approve all decisions in matters of National Policy, alumni, public relationship, legal action, and controversy which may be referred to its Board of Trustees by the National Chapter, the National Council, or the Tau Beta Sigma Alumni Association Executive Council. The decision of the Board of Trustees shall be final in all cases

Proposal: "2.101 The Corporation, which may be referred to as the Board of Trustees by the National Chapter, the National Council, or the Tau Beta Sigma Alumni Association Executive Council, shall have jurisdiction over all component parts of the Sorority and shall represent them and approve all decisions in matters of National Policy, alumni, public relationship, legal action, and controversy. The Corporation will also review current funding/fundraising programs and any new proposals for programs designed to increase revenues. The decision of the Board of Trustees shall be final in all cases

Rationale: In order to distribute all the responsibilities of the Ways and Means Committee, the Board of Trustees has assumed the responsibility of fundraising efforts at the national level.

e. Addition of Budget Review and Approval for the National Chapter

Proposal: "3.802 A thorough report of the National Budget for the next biennium shall be submitted by the NVPME at each regularly called Convention of the National Chapter. The Budget shall then be approved by the National Chapter."

Rationale: The Committee wanted to ensure that a thorough review of the budget will always be given to the National Chapter, as well as clarifying the ability of the National Chapter to approve the budget.

Due to the high number of proposals passed along by the National Council, the committee was able to discuss most, but not all of these proposals that were passed along. Additionally the committee did discuss and add a proposal to be reviewed and voted upon, being the addition of Budget Review and Approval for the National Chapter.

The Committee charges the 2027 Jurisdiction and Committee with the following:

- 1. Review the report of the 2025 Jurisdiction and Committee.
- 2. Review the Constitution and make sure the language is clear and specific.
- 3. Further evaluate the usage of the term "in good standing" and clarify the meaning.
- 4. Review and evaluate the national budget review and approval process, and clarify any relevant definitions
- 5. Consider the deadlines in the constitution and evaluate if they are still effective. timeframes and also consistent across the document.
- 6. Charge the 2027-2029 National Council with updating Constitution article numbers.

The Committee charges the 2025-2027 National Council with the following:

- 1. Continue to advertise the deadline of the proposed jurisdiction changes more publicly.
- 2. Update article numbers within the constitution in accordance with 2025 changes to the constitution.
- 3. Propose the specific desired phrasing to suggested changes to the National Constitution when identifying issues.
- 4. Cross reference the updated 2025 constitution with the previous two copies of the Constitution (2021 and 2023) and the voted on changes in order to identify inconsistencies.

Review of the 2023 Membership and Expansion Committee Report:

The committee reviewed the report of the 2023 Membership and Expansion Committee.

Review of the 2023-2025 National Vice President for Membership and Expansion Report:

The report of the 2023-2025 National Vice President for Membership and Expansion was presented to the delegation during a separate session meeting. The committee instead reviewed the 2023-2025 National Curriculum Development Committee report. The committee appreciated the adult education audit and commended the efforts made to ensure the Overture curriculum was written for adult learners. They were excited to hear about the future plans to digitize Rondo activities, allowing for virtual and asynchronous lesson options.

Review of the Implementation, Content and Application of Overture:

The committee enjoys having access to both lecture and activities through Overture. Having both resources makes digesting and retaining the curriculum more accessible to different learning styles. However, the committee would like to see more opportunities for the substitution of lecture portions with activities. This would help the education process to feel more diverse and engaging. The committee also found some of the lessons to be too lengthy and overwhelming. They suggest reviewing modules to ensure the curriculum is concise and easy to follow. The committee enjoys the flexibility of Overture, allowing chapter VPMs to cater lessons to fit the needs of their Membership Classes. A sentiment shared by the committee members was the need for a way to increase retention during the MC process. They suggested adding review sessions to the beginning of each module that specifically go over the high points of the previous module. Ensuring new members are retaining information will not only give them a more enriching and positive educational experience, but also cultivate more knowledgeable and confident chapters. Finally, the committee was very interested in the update of the curriculum to include the history of HBCUs and their cultural differences to PWIs. This curriculum addition could also highlight the differences we see in other multicultural serving institutions.

The committee expressed frustration with the speed of Membership Education Plan revisions. They note occasions where they do not receive notification of what needs to change until they are upon the time for recruitment events, forcing them to cancel and reschedule. The committee emphasized the importance of ensuring chapter VPMs are properly educated on Overture and its proper use. They believe that this could best be done through a meeting between chapter and district VPMs before the Membership Intake seasons begins. Some committee members noted feeling like they lacked the proper information on how to contact their District Officers and

Counselors. It is vital that this information is accessible to ensure new and returning members have a place to go to ask questions and voice concerns.

Some committee members shared that utilizing multiple chapter officers during the Membership Education process significantly increased understanding of certain topics. A specific example mentioned was bringing in the chapter's Parliamentarian to answer questions surrounding Robert's Rules and their application in chapter meetings.

Review of the Overture resources:

The committee believes that the Educator's Handbook, while long, is a great resource for VPMs to navigate Overture and the Education Process. The committee also stressed the importance of creating more resources for Membership Candidates. The goal of these resources would be to have something that caters to every learning style. The committee found that the National Website can be hard to navigate and sometimes crashes. This can be frustrating when looking for hyper-specific information or trying to submit funds for paperwork. The committee noted that the Overture presentation slides did not always contain all of the information specifically taught in a given module. Having a resource that chapter VPMs can simply download and use for a module lesson would be well utilized during busy times of the semester. The committee strongly desired the creation of a shared space for chapter VPMs to share presentations, activities, fundraisers, and other ideas with each other. This was mentioned to be especially helpful for when a VPM is stressed and may need to use someone else's presentation for a certain module. Not only would a resource like this foster collaboration and sisterhood throughout the nation, it will also give insight into the innovative ways chapter VPMs have taught the Overture curriculum.

Review of the Implementation, Content and Application of Rondo:

The committee agreed that there is a place for continuing education in all events. The committee found that the implementation of incentives (certificates, awards, FoF stripes, etc.) could be useful in increasing the usage of Rondo. The committee also discussed the creation of smaller Rondo lessons that members could better implement during busy times in the academic year.

Review of the Expansion Plan of the Sorority:

A sentiment shared by the committee was the desire to support petitioning groups and new chapters through their education process and early years. This was suggested to be done through a multitude of resources. The committee wants to see the creation and maintenance of either one nationally-shared or multiple district-specific calendars detailing the dates of Rituals, Installations, Probates, and more. This would give chapters time to prepare to travel in order to support their sisters. The committee also expressed a desire for National or District Directories that include the contact information, social media handles, and mailing addresses for all Active chapters. The committee discussed a desire for more visibility of the expansion efforts of the

sorority on social media platforms. Posts can be created at the end of each semester, much like Spotify wrapped, to update the sorority on these efforts. The committee also expressed an interest in seeing more posts from the District Councils showcasing individual chapters on the district social media pages. This can be done through tagging or individual posts. Finally, the committee was interested in increasing outreach efforts into high school band programs. They discussed how servicing these programs not only go along with our purposes, but also allow for early recruitment and more visibility of our organization.

Charges:

The Committee charges the 2027 Membership and Expansion Committee with the following:

- 1. Review the report of the 2025 Membership and Expansion Committee.
- 2. Review the report of the 2023-2025 National Curriculum Development Committee.
- 3. Review and Discuss the Overture curriculum by providing feedback on the implementation, content, and application by chapters.
- 4. Review and Discuss all Overture resources on the Overture Landing Page by providing suggested improvements.
- 5. Review and Discuss the Rondo curriculum by providing feedback on the implementation, content, and application by chapters.
- 6. Review and Discuss the Expansion Plan of the sorority by providing feedback on strategic planning, proactive recruitment, and material development.

The Committee charges the 2025-2027 National Curriculum Development Committee with the following:

- 1. Review the report of the 2025 Membership and Expansion Committee.
- 2. Host meetings with the District Vice Presidents for Membership to train them on the proper use of Overture, allowing them to teach the curriculum to Chapter Vice Presidents for Membership.
- 3. Overture charges and suggestions include the following:
 - a. Create a study resource for Membership Candidate use.
 - b. Review the length and order of the Modules to ensure they are introduced in a way that would be the most manageable and make the most sense to Membership Candidates.
 - c. Create a standardized way Chapter Vice Presidents for Membership should approach completing make-up lessons with Membership Candidates who miss education meetings.
 - d. Uphold the values of the DEIA Committee, collaborating with them to ensure Overture's language is inclusive to all.

- e. Update the current Overture curriculum to include more history behind the formation of HBCU chapters and chapters from other multicultural serving institutions. Include cultural differences between these chapters and PWIs to help showcase the diversity of our organization.
- f. Update the current Overture presentation slides to ensure they contain all of the information required for Membership Candidates to learn.
- 4. Rondo charges and suggestions include the following:
 - a. Create Rondo lessons that go into the history behind the formation of HBCU chapters and chapters from other multicultural serving institutions. Include cultural differences between these chapters and PWIs to help showcase the diversity of our organization.
 - b. Create new lessons that are more condensed and accessible for chapters running low on time.
 - c. Explore the implementation of incentives to encourage chapters to use Rondo. This could be done through Focus on Five or other means.

The Committee charges the 2025-2027 National Vice President for Membership and Expansion with the following:

- 1. Review the report of the 2025 Membership and Expansion Committee.
- 2. Collaborate regularly with VPMs at the chapter and district levels to find ways to best support members.

Focusing on our time together since meeting last biennium in Orlando, we have accomplished quite a bit. Here's some basic highlights of Tau Beta Sigma in the past two years:

-The implementation of our new Membership Database System, OPUS, has been a wonderful success! We are able to manipulate our data in ways we've never dreamed possible, with the implementation of the integration of an embedded online payment system happening very soon-making OPUS your one stop shop for paperwork, resources, and staying financially secure! Big shout outs to Shalyn Nystrom and Aaron Moore for their tireless work to make this successful.

- -In September 2023, we welcomed Southwest District Counselor Katie Dukes to the role of Vice President for Communication & Recognition, and she has been a wonderful addition to our team!
- -There has been some intense turnover at our National Headquarters, starting and ending this biennium with an almost entirely different staff. In the beginning of last year, we gave a heartfelt goodbye to our National Executive Director, Steve Nelson, and through an extensive process, I'm so excited to have Past National President and incredible human Dollie O'Neill take the role this past April, helping to right our ship towards the future.
- -With the stepping down of National President Siobhan Wilkes Bratcher, the existing electable National Council all elevated one position, and we were lucky to strike gold once again with the appointment of Southeast District Counselor Kelsey Reilly to the National Vice President for Communication & Recognition role in March of 2024.
- -Through the teamwork of Allison and I, we were able to welcome six new chapters to the Sisterhood, not only contributing to the highest membership numbers and growth since before Covid, but the implementation of a continued onboarding process for the following year for the new chapters-ensuring they are provided the tools they need to succeed for their futures.
- -Through a wonderful partnership with our amazing Chapter Visitation Associates, we have succeeded in the highest number of chapter visits this biennium, with 119 of our chapters working with a designated volunteer to ensure their growth and provide preventative support for their challenges. I'm so excited for the potential to start the gradual process of bringing back in person visits-which in my opinion gives the most crucial resource for the success of our chapters.
- -To better fit our needs and to evolve with the technology available, we transitioned to a new software for online registrations for our District and National Conventions, and it's gone great!

Personally, there are three specific dates that have impacted my life immensely, and I want to share what happened, how they affected me, and how they might have impacted you in some small way. (TW: this talks about death of loved ones)

- -November 11, 2023: After a couple month illness, my Dad passed away. This hurt so much, and still hurts now, and I know I still will for the rest of my life. He taught me how to be kind, how to work hard, and was the best Dad. He didn't quite understand what this was, but it didn't matter, because he knew it mattered to me, and he was a frequent financial supporter of the Sisterhood throughout our last Giving Tuesdays.
- -December 10, 2023: Siobhan told us at the end of our December council call that when she was taking her Maternity leave in March, she would also be stepping down as National President of

the Sorority. This was and still is hard. There's still a lot of emotions with this, but I can never blame her for doing what she thinks is best for herself and the organization. This action got my head out of a fog and forced me to put one foot in front of the other for the next four months as we prepared to take on new roles in the organization, while keeping the organization moving forward during the time being.

-March 28, 2025: After going through different illnesses for about six months, my Mom passed away. I had longer to prepare for this one, and thought it wouldn't be as difficult because I've been through one major loss already, but I was wrong. I made the decision to go to the Southwest District Convention, and I don't know if I'll ever be able to forgive myself for doing so. I'm working on it.

I shared those very personal moments of my life, to give some advice to everyone in this room:

- -There will be times in your life you prepare for, and it will most likely NEVER go the way you want it to. Do the thing anyway. You could have dreamed for years about a certain situation, but should you give up that dream if it happens a different way? Heck no.
- -There will be a time in your life that you will feel like you're having the worst time of your life, and you have to acknowledge that. Ignoring the fact you're miserable will help nothing. Instead, look towards when things will get better. You'll get through it. You'll get through it better if you acknowledge it sucks.
- -When there are days where it's hard to do anything, you gotta put one foot in front of the other. Think about your selfless nature, and do it for everyone else. Sometimes, we live this life not for ourselves, and that gives our life meaning.
- -Always lean on people you trust. That doesn't mean thank them constantly, but just appreciate their presence, and let them help you. Being vulnerable is the hardest thing, but that's why your people exist. I bet each of you in this room can think of at least one Sister that you trust and love. I'm so lucky to have at least a hundred Sisters in that category, a lot of them in this room.

Speaking of loving on my people, I'd like to say thank you to some Sisters and Brothers who have helped shape my journey in Tau Beta Sigma:

To the Past National Presidents: you are all so kind, and I'm forever grateful for how welcoming, patient, and supportive you've been with me over this past biennium specifically. I'm so excited to join this exclusive club and help support our next generation of leaders.

To the Headquarters Staff: To serve 300 chapters and 8,000 students with only six full time staff members is insane! Thank you for your patience, support, hard work, and love for the Sisterhood that made this partnership a dream. Big shoutout to Dollie O'Neill for EVERYTHING. I said it when you first applied to the NXD position, and I'll say it in public: we absolutely do not deserve you, and the fact that you went out and learned the world, to come back to run our organizations simply because of your passion for it, is amazing. Thank you!

I have had the opportunity to work with 1 set of District VPMs, and 2 sets of District Presidents with 20 amazing individuals that will continue to inspire me in this crazy journey of Tau Beta Sigma. Whether you were elected during your convention or appointed mid-year, you are all incredible humans that I'm so lucky to have the opportunity to work with.

To the Board of Trustees and TBSAA EC: You make up this trifecta that made this awesome biennium happen, and I'm grateful for all of you. I admire, respect, and appreciate each one of you. To Thea and Rosalyn specifically-thank you for your patience with me, and welcoming me into our leadership group that makes our volunteer groups run.

To the CVA group: You are the heartbeat of this organization. Your boots on the ground, or on the Zoom this biennium for a unique mix of in person and virtual chapter visits/correspondence, provide an invaluable, selfless service to the organization. Thank you!

To the Counselor group: The best gig in the sorority! I appreciate your continuous hard work and passion for the organization. Watching you work now with the students and how much you sacrifice fills my heart so much. Thank you.

To this incredible National Council:

Kelsey-you are the definition of kindness, and such a good soul. I've said this to you in private but will say it in public-I would take a thousand of you, where you keep your head down and do the work with passion and intelligence without the fanfare, over superficial anyday. I can't wait to keep watching your beautiful kids grow up!

Katie-I know none of this was what you expected, and I'm so sorry for that. You acclimated to all of this so much quicker than we deserved you to, and you'll keep catching on, just hang in there. I'm so appreciative of your willingness to serve, and will always be your ear during the next couple of years.

LaToya-What a fantastic woman in music! I love that you see a challenge, and you are excited to take on that challenge head on and thrive through it. Thank you for your amazing work for our students, and I really look up to you.

Allison-Our relationship is so unique, and my favorite part of this organization for the past 10 years. Man, we drive each other crazy because we are the exact opposite, and I'm sure our separate friend circles are ready to stop hearing us talk about how different we are. I say this as a compliment when I say you are the little sister I always wanted-where you follow whatever I do and do everything 10 times better than I ever could. I love you so much, and I have no concerns about this next biennium, because you've absolutely got this. We have shared so many unique experiences through the Sisterhood, especially these last two years, and I don't know if I would have made it without our impromptu vent sessions, where we periodically join sides in frustrations. Sisters forever.

To my Midwest Crew:

Shalyn-You continue to define what it means to be selfless, and I don't think anyone in this room fully comprehends everything you continue to do for Tau Beta Sigma. Thank you for your passion, and continued friendship.

Zack-We all saw how special you were as a student, and how you've dedicated so much to Tau Beta Sigma is amazing. Some of my favorite times in the past fifteen years are our roadtrips, and running Midwest District Conventions together. You let me speak my mind, cry around you, and you are the best listener I've ever met. I love you, and appreciate your kindness and friendship.

Adrienne-Dang, what a journey. I am not a fraction of the Sister you are on a daily basis, and your tireless efforts have helped keep me going. I said this in 2021 and I'll say a modified version of it now-you have modeled for me what being a Sister in leadership should look like.

Jason-I think I blocked out my first two years as a Sister because you weren't here yet, and our journey together is in tandem. We joke around a lot about slingshotting each other into more important positions in the Sorority, and we've made it. Things are still the same from 20 years ago where someone's mad at one of us, they yell at the other person. Now, rather than just Zeta Nu Sisters, it's Sisters and Brothers from across the country.
